Changes of Address: Please be reminded to inform us of any change of address as soon as possible. We cannot guarantee transportation should this information not be provided in advance, and you may be required to transport your child temporarily until transportation can be confirmed.

Revised Cafeteria Prices: Please note that cafeteria prices have been revised for the upcoming school year, to better reflect costs incurred. You should receive a revised price list in your child's report card and this will also be posted to the school web-site.

Consumable & Supervision Fee Payment Procedures: Please note that the first notice of the 2011 - 2012 Consumable and Supervision Fee Bill is included with this newsletter. **Billing will again occur in 2 phases;** the first

beginning now with **Supervision Fees** being charged. Following in the Fall will be the issuing of the 2nd phase of billing that charges for all other consumable materials issued to your child (workbooks, agendas, etc...). The cost per item will be calculated based on our bills and the exact cost will be billed to you in October/November. We ask that you complete the form and include this with your payment. You may mail these in to us over the summer, or send it through your child's homeroom teacher during the first weeks of school (enclose form & payment in a sealed envelope with your child's name clearly identified on the front). **Please note the September 16th** deadline for payment of this **first** bill.

Summer Closure: Please note that the school (including the office) will be closed from July 11th to August 22nd. This is to accommodate staff vacations, cleaning and preparation for the upcoming school year. Thank you in advance for your understanding and cooperation.

If you have questions pertaining to the report card, or other concerns, please call the school during the June PP days as the staff will not be in a position to assist you on the last day of school.

Please note that class lists are now fixed. We are not in a position to accept specific class placement requests. Your child will remain in the homeroom that has been assigned.
