2. QUORUM AND ADOPTION OF THE AGENDA

3. <u>APPROVAL OF THE MINUTES OF THE MEETING OF NOVEMBER 28, 2017 AND OF</u> <u>THE SPECIAL MEETING OF DECEMBER 19, 2017</u>

Resolution No. ETSB18-01-68 <u>Approval of the Minutes of the Meeting of November 28, 2017 and of the Special Meeting</u> of December 19, 2017

IT WAS MOVED BY Commissioner R. Gagnon to take the meeting in-camera at 7:10 p.m.

Out-of-Camera

The meeting was taken out-of-camera on a motion by Commissioner R. Gagnon at 7:22 p.m.

The Secretary General presented the following resolution:

7.1 Expulsion Recommendation – Richmond Regional High School

Resolution No. ETSB18-01-69 Expulsion Recommendation – Richmond Regional High School

WHEREAS, in the last two years at Richmond Regional High School (RRHS), Student A has often been suspended from school for different reasons, mostly related to violence and not respecting the rules;

WHEREAS, as a result of this inappropriate behavior, this student was out of school for the last part of the 2016-2017 school year, receiving home services;

WHEREAS, on many occasions, support was offered to Student A;

WHEREAS the possibility to be transferred to Massey-Vanier High School in a more appropriate program was offered, including transportation;

WHEREAS the family refused this offer;

WHEREAS Student A returned in September 2017 to RRHS with a contract offering support;

WHEREAS the parents and Student A signed the contract in which it was stipulated that not respecting the rules could result in an expulsion by the Eastern Townships School Board;

WHEREAS, as a school, RRHS can no longer offer support considering the level of difficulties of Student A;

WHEREAS, after a follow up by the "core team meeting" with administrators, professionals and teachers, it was decided that Student A's behavior was putting RRHS's population at risk and, therefore, request that Student A be expelled from RRHS;

WHEREAS the Director General suspended Student A with the offer of home services until the Council meeting and informed Student A and the family that they were welcome to present their point of view at the Appeal Committee;

WHEREAS home services were refused and the family did not exercise their right to appeal;

IT WAS MOVED BY Commissioner G. Holliday that Student A be expelled from RRHS, effective immediately.

7.1.1 <u>Approval of the Deed of Establishment – Campus Brome-Missisquoi/Vocational</u> <u>Training Centre</u>

Resolution No. ETSB18-01-70 <u>Approval of the Deed of Establishment – Campus Brome-Missisquoi/Vocational Training</u> <u>Centre</u>

WHEREAS the Deeds of Establishment were approved as deposited, without the Campus Brome-Missisquoi/Vocational Training Centre, at the meeting of November 28, 2017 (Resolution No. ETSB17-11-53);

WHEREAS the Deed of Establishment was sent to the Campus Brome-Missisquoi/Vocational Training Centre Governing Board and to the members of the Parents' Committee for consultation;

IT WAS MOVED BY Commissioner R. Gagnon to approve the Campus Brome-Missisquoi/Vocational Training Centre's Deed of Establishment 2018-2019.

7.2 Confirmation of the Head Office Administrative Structure 2017-2018 – Amendment

Resolution No. ETSB18-01-71 Confirmation of the Head Office Administrative Structure 2017-2018 - Amendment

WHEREAS section 134 of the Regulation respecting *Certain Conditions of Employment of Senior Staff of School Boards and of the Comité de Gestion de la Taxe Scolaire de l'Île de Montréa*l states that the School Board must confirm the Head Office Administrative Structure, as it has been amended;

WHEREAS the Commissioners have reviewed the proposed amended Administrative Structure for the Head Office, including the appropriate modifications and adjustments for the rest of the 2017-2018 school year, during the January 23, 2018 Executive Committee meeting;

WHEREAS the Eastern Townships Association of Administrators (ETAA) has been duly consulted on the amended structure;

WHEREAS this amended administrative structure is to take effect immediately;

IT WAS MOVED BY F. MacGregor that the Council of Commissioners approve the amended Head Office Administrative Structure for the balance of the 2017-2018 school year, effective immediately.

7.3 <u>Recommendation for the Implementation of a Community Learning Centre (CLC)</u> <u>Approach with an Expanded Model at Sunnyside Elementary School</u>

Resolution No. ETSB18-01-72 <u>Recommendation for the Implementation of a Community Learning Centre (CLC)</u> Approach with an Expanded Model at Sunnyside Elementary School

WHEREAS the Eastern Townships School Board (ETSB) is already part of the provincial network of Community Learning Centres (CLC) with four (4) CLCs at Pope Memorial Elementary School (Sawyerville Elementary School), Richmond Regional High School (Drummondville Elementary School, Asbestos-Danville-Shipton (ADS) Elementary School, St. Francis Elementary School), Princess Elizabeth Elementary School (PEES) and Butler-Farnham Elementary Schools;

WHEREAS \$15 000 in funds are available from the *Entente Canada-Québec* to implement an expanded model of the Princess Elizabeth Elementary School CLC at Sunnyside Elementary School for the rest of the 2017-2018 school year (until the renewal of the *Entente* in June 2018);

WHEREAS the CLC approach has proven to be an efficient tool in supporting community vitality and authentic student learning at the ETSB;

WHEREAS Sunnyside Elementary School has already a relationship with its community and considers that there is a potential for creating new partnerships through the CLC approach;

WHEREAS the CLC initiative will be a benefit to the students, the parents, the school staff and to the community;

WHEREAS a CLC can also be a strong tool for the recruitment of students with its community based approach;

WHEREAS the ETSB will have to engage a coordinator, monitor the operation and provide support for the expanded model;

WHEREAS since the CLC approach is part of the 2017-2021 Communication Development Plan, this proposal is directly aligned with the plan;

IT WAS MOVED BY D. Brodie to accept the request from Sunnyside Elementary School, for the implementation of the Community Learning Centre (CLC) approach at Sunnyside Elementary School as an expanded model of the Princess Elizabeth Elementary School CLC.

Carried unanimously

The Director General presented a written report in which the following items were highlighted:

16. **QUESTION PERIOD**

Q: What is the policy regarding the students being exposed to a temperature under minus twenty degrees at school?

R: Emergency cases can happen. Students cannot be sent back home during the day.

Q: Will Heroes' be considered for major repairs to improve the building? *R:* Yes, the same thing as all the other Eastern Townships School Board buildings.

Q: Are the ETSB policies aligned with the Charter of Rights?

R: The policies are revised on an ongoing basis. Administrators and professionals are part of the consultation and updates.
