9.3 Audit Advisory Committee

9.3.1 Finance

The Chair of the Audit Advisory Committee, Commissioner J. Humenuik, presented the following resolutions:

9.3.1.1 <u>Delegation of Powers for Notice of Execution</u>

Resolution No ETSB18-02-75 <u>Delegation of Powers for Notice of Execution</u>

WHEREAS the Eastern Townships School Board (ETSB) is committed to providing the best educational services possible taking into account its resources and therefore is also committed to good fiscal management;

WHEREAS Section 303 of the *Education Act (the Act)* gives school boards the right to levy a school tax and Section 312 of the same act requires the Council of Commissioners to set the school tax rate at the time of the adoption of the budget of the school board;

WHEREAS Section 326 of the Act states that the Director General may collect, with legal costs, the taxes due by any owner by the seizure and sale of his movable property not exempt from seizure that is found in the territory of the school board.1988, c. 84, s. 326; I.N. 2016-01-01 (NCCP);

WHEREAS Section 327 of the Act states that the seizure and sale are made under a notice of execution prepared by the chair of the school board and filed with the court office by the clerk of the Court of Québec or the clerk of the Superior Court, according to the amount of the claim. The clerk shall file the notice of execution upon production of a certificate from the chair of the school board attesting the amount of the debt and the fact that it is due and owing.1988, c. 84, s. 327; 2008, c. 29, s. 34; I.N. 2016-01-01 (NCCP);

IT WAS MOVED BY Commissioner J. Humenuik that the Chairman of the Eastern Townships School Board, acting through the ETSB's Director of Finance, gives the mandate to the firm Huissier de Justice S.E.N.C.R.L.to prepare and deposit to the clerk of the Court of Québec or the clerk of the Superior Court the notice of execution according to article 327 of the education act of Québec and this in accordance with the President Certificate attached to the execution slip.

IT WAS FURTHER MOVED BY that the Finance Director may give the power of notice of execution to the bailiff.

Eastern Townships School Board - International Student Program - Agent fees

WHEREAS the Eastern Townships School Board's (ETSB) International Student Program's (ISP) mission is to promote opportunities to expand our understanding of multicultural realities, thus promoting the development of global citizens;

WHEREAS a part of the mandate of the International Student Program is to increase student population within ETSB schools and centres;

WHEREAS in order to limit its financial risk and assure the success of its ISP, the ETSB is working with agents and agencies that offer support to both parties in the recruitment of students and the bridging of cultural and linguistic barriers;

WHEREAS the ETSB works within the regulatory frameworks established by Immigration Canada, le *ministère de l'Immigration, Diversité et Inclusion (Québec)*, and by the guidelines of the *Canadian Association of Public Schools International*, a non-profit organization comprised of 127 publicly-funded districts and *Éducation Internationale*, a non-profit cooperative funded by the *ministère de l'Éducation et de l'Enseignement supérieur* (MEES);

WHEREAS the ETSB cannot, on a yearly basis, project an exact number of international students recruited in its ISP, nor can it project which agency they will be recruited by;

WHEREAS a contractual agreement stipulates a percentage of the tuition fees to be paid to agents, on the basis of results;

WHEREAS the percentage for youth sector programs and for the adult programs is dictated by the global market for International Student Programs;

WHEREAS agent or agency fees for recruitment of international students are paid upon presentation of invoices following official student counts and which follows the usual commercial practice;

WHEREAS the ETSB will be invoiced to the amount of \$242,367.74 for all students recruited from July 1st, 2016 to June 30th, 2017;

WHEREAS the following agent(s) presented invoices totaling an amount exceeding \$50,000:

Merpont International \$59,000

WHEREAS we predict agency fees for students recruited during the 2017-2018 school year to represent an approximate total of \$216,500.00

WHEREAS it was moved by resolution #ETSB17-03-55, on March 28, 2017, that a company known today as *Ideo Installation Steve Brault Inc*, be awarded a contract in the amount of \$136,376, including professional fees and taxes, for the project stated above;

WHEREAS during the project some modifications of additional work needed to be done;

WHEREAS the amount of \$31,860 to pay for all modification orders, additional work and professional fees (including taxes), is required to finish the project;

bâtiments 2017-18 (Mesure 50621), MDB - Maintien des bâtiments 2016-17 (Mesure 50621) and MDB - Maintien des bâtiments 2015-16 (Mesure 50621);

WHEREAS the Eastern Townships School Board (ETSB) in collaboration with the *Commission scolaire du Val-des-Cerfs (CSVDC)* wants to replace a part of the roof at Massey-Vanier High School;

WHEREAS the CSVDC is in charge of the call for tenders for the Massey-Vanier High School Campus;

WHEREAS the total cost of the project is shared 50% / 50% between the CSVDC and ETSB;

WHEREAS the lowest bid in the total amount of \$547,400 (excluding taxes), was received from the company Lacasse & Fils Maîtres couvreurs inc;

WHEREAS if additional funds are required to complete the project, monies will be taken from the MDB - Maintien des bâtiments 2017-18 program and/or under the RTA - Réfection et transformation des actifs program;
