## 5. RECOGNITION OF EXCELLENCE

This month the Council of Commissioners and Senior Administrators of the Eastern Townships School Board would like to signal the following:

- A small group of students at Princess Elizabeth Elementary School (PEES) are hoping their efforts will have a positive impact on children who are hospitalized in the paediatric department at the *Centre hospitalier universitaire de Shebrooke* (CHUS). Grade five students at PEES; Hailey Harison-Dostie, Kezia Loewen, Zoe St-Martin and Shyann Roy, were planning on holding a slime sale outside one of their homes. When PEES teacher Shannon Greenwood heard about the plan, she encouraged the students to think big and with a little guidance it turned into a, slime, drawings and snacks fundraiser to be held at school. All of the products are hand made by the four students and all of the proceeds will be used to purchase toys, games, etc., for children in the paediatric department at the CHUS in Fleurimont, to make their stay a little easier. So far the students have held two of the four planned sales and have raised \$400! The next step will be to get the monies raised and the toys purchased to the hospital. We would like to take this opportunity to congratulate the students on their entrepreneurial skills and their sense of community in reaching out to others and Ms. Greenwood for her support and guidance;
- Some Alexander Galt Regional High School (GALT) students were recently in Ottawa as part of the Ambassadors of Change Program sponsored by the Canadian Society for Yad Vashem, Holocaust Education and Commemoration. Organized by GALT teacher Stephanie McCully, students in the secondary 3 Enriched History/English class were given the opportunity to travel to Ottawa last week and visit the Canadian War Museum. While there they met with survivors of the Holocaust, participated in small group discussions and the National Holocaust Memorial Ceremony. Guest speakers included leaders of the NDP and the Conservatives as well as the Minister of Defense and survivors. As expressed by one the teachers accompanying the group Stephanie Brown, "what a great opportunity for our students and kudos to Ms. McCully for organizing this".
- In show business they say, the show must go on and that is exactly what ETSB students and teachers did last week when the ETSB's Annual United in Music concert was postponed due to a 'snow day'. Originally scheduled for April 16<sup>th</sup> the concert was held on the 18<sup>th</sup> at Massey-Vanier High School. Though some elements of the show had to be rearranged, the concert was once again a huge success under this year's theme, "Songs of Change". In all close to 400 students performed for the finale, which was preceded, with each school performing their own number. Congratulations once again to the organizers and all the students who participated;

- On April 18<sup>th</sup> the ETSB held its Annual Volunteer Recognition Event in Magog. In attendance were volunteers from elementary and high schools who had been nominated as this year's outstanding volunteer for their school community. As in previous years, the volunteers chosen by the ETSB Central Parents Committee as, Volunteers of the Year were announced. This year the individuals chosen were: Shawn Jersey from Mansonville and Mandy Deners Hinds from St. Francis as the Volunteers of the Year Elementary level and Michelle O'Brien from Massey-Vanier and Shane Kydd from Richmond Regional as the high school Volunteers of the Year. Congratulations to all the nominees and the volunteers of the year. As well we want to extend our heartfelt appreciation to all the volunteers in all our schools and centres who give so selflessly of their time and expertise.
- On behalf of the Council and senior administrators of the Eastern Townships School Board, we would like to extend our congratulations to Bradley Daignault from Alexander Galt Regional High School and Taylor Dubois from Richmond Regional High School on each receiving the Quebec Lieutenant Governor's Youth Medal. ## 7.3 Renewal of the Consolidated Purchasing of General Insurance Contract

Renewal of the Consolidated Purchasing of General Insurance Contract

**WHEREAS** each school board can contract an insurance, in accordance with articles 178 and 270 of the *Loi sur l'instruction publique*;

**WHEREAS** for several years, the Council of Commissioners authorizes the participation of the Eastern Townships School Board in the *Regroupement des commissions scolaires de la Montérégie et de l'Estrie en matière d'assurances*;

**WHEREAS** the consolidated purchasing experience has been beneficial for the Eastern Townships School Board;

**WHEREAS** it was resolved by resolution ETSB17-02-46, on February 22, 2017 to participate in the *Regroupement des commissions scolaires de la Montérégie et de l'Estrie en matière d'assurances*:

**WHEREAS** the school board's insurance contract with BFL Canada, lowest bidder in conformity, will expire on June 30<sup>th</sup> 2018;

WHEREAS it is in the interest of the School Board to continue its participation in the consolidated insurance for the Montérégie and Eastern Townships region;

#### IT WAS PROPOSED BY COMMISSIONER J. HUMENUIK AND RESOLVED:

- to maintain the authorization granted to the Eastern Townships School Board to participate in the Regroupement des commissions scolaires de la Montérégie et de l'Estrie en matière d'assurances:
- to mandate Guy Turcot de GT&A Gestion des risques Inc and les Consultants d'assurance Adelson & Associés Inc to represent the Eastern Townships School Board in all the necessary phases for the renewal of the general insurance contract for the 2018-2019 school year, by mutual agreement or by a call for tenders, in accordance with the method to be used;
- in the event that a consolidated call for tenders was the chosen option, to mandate the Commission scolaire de la Région de Sherbrooke to conduct a public call for tenders in accordance with the procedures and policies in effect at that school board;
- in the event that a consolidated call for tenders was made concerning insurance, that the Eastern Townships School Board act in solidarity with the other school boards participating in such a process;
- to request that a recommendation for the purchase of insurance for 2018-2019 be filed by the Director of Operations by June 1st 2018, in order to ensure that it is submitted on time to the Executive Committee (or Council of Commissioners).

IT WAS FURTHER MOVED that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Assistant Director General can also sign.

Realization of a Study Aimed at the Regionalization of Business Services of the Four **Estrie School Boards** 

WHEREAS a major challenge for businesses in the region is the recruitment of skilled labor;

WHEREAS the school boards are able to offer training allowing companies to have access to this qualified workforce, both through vocational training and customized training;

WHEREAS the customized training offered by Estrie School Boards' Business Services often makes it possible to respond more quickly and more appropriately to the needs of businesses;

WHEREAS these customized training courses are offered by the four Estrie School Boards in different spheres of activity and at different locations on the territory of the Eastern Townships;

**WHEREAS** during an extended consultation with companies, they expressed the need to be able to go to one place for their customized training needs;

**WHEREAS** in this context, work has been undertaken to evaluate how the four Estrie School Boards, three Francophone and one Anglophone, could offer a regional business training service;

**WHEREAS** in the context of this study, the regionalization of Business Services where vocational training centres are contributing to the roll-out of programs to address the labor needs of businesses in the region;

**WHEREAS** by merging, Business Services become a real lever for the maintenance and development of vocational training at the regional level, for the benefit of the Francophone and Anglophone communities;

WHEREAS a regionalization of Business Services allows:

- the creation of regional centres of expertise;
- · the consolidation of the offer of services in vocational training;
- more qualified graduating students;
- a better response to the training needs of companies;
- access to a qualified workforce;
- response to the orientations of the MEES based on strong and more effective regional concertation as a lever to support regional development;

IT WAS PROPOSED BY COMMISSIONER J. HUMENUIK AND RESOLVED to authorize the Eastern Townships School Board to participate in the realization of a study aimed at the regionalization of Business Services of the four Estrie School Boards. IT WAS FURTHER RESOLVED that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Assistant Director General can also sign.
