Basic Guidelines for the transportation of students registered in a school and residing in the jurisdictional territory of the Eastern Townships School Board

- 1) Students residing (permanent home address) in the transportation territory of a local elementary school will be provided free transportation to and from that school in the morning and afternoon (excluding those within walking distance).
- 2) Secondary students residing in the transportation network feeding a secondary school will be provided free transportation to and from that school in the morning and afternoon (excluding those within walking distance).
- 3) Students defined in Articles 1) and 2) who are not able to access specific services due to a board resolution changing a deed of establishment will be provided free transportation services in the morning and afternoon to a board designated school offering such services.
- 4) Students defined in Articles 1) and 2) who are affected by the opening or closing of a school will be given transportation services to a school designated by the School Board. The School Board reserves the right to identify the students who wish to continue their educational program in a specific school and may agree to provide transportation for a limited time on a space-available basis.
- 5) Parents who request educational services in those schools not defined in Articles 1) and 2) must provide their own transportation to and from that school for their child(ren). This choice should be exercised during the registration period.
- 6) The School Board may provide transportation for students defined in Article 5) and in such cases reserves the right to charge a fee which will be payable to the Eastern Townships School Board and credited to the transportation department. Students paying for available space will be charged \$250.00 per year. All other transportation services must be self-financing.
