Resolution No. ETSB 20-01-41

Approval of the Minutes of the Meeting of the Council of Commissioners held on November 26, 2019

8. <u>REPORTS</u>

8.1 DIRECTOR GENERAL'S REPORT

The Interim Director General, Michel Soucy, had nothing to report.

8.2 REPORT FROM THE CHAIR

The Chair of the Council of Commissioners, M. Murray, read the following report:

Welcome to the new decade. Finally, we have a decade; the twenties, that is easy to say, easy to remember and resonates with the echoes of the Roaring Twenties of the last decade. Let's look forward together to a great second half of this academic year and a great decade ahead for public education.

In the spirit of fresh beginnings, members of the Council have been devoting time and energy to improving our model of governance. With the help of an outside consultant, we have begun to understand an approach to governance that can apply, not only to how this Council relates to the employees, the parents and the students of this School Board, but to how each administrator, teacher, professional and support staff member can better understand how they contribute significantly to the success of the whole organization. Our governance focus will be on Clarity, Commitment and Accountability. We have been made aware through surveys and interviews that the most common need identified by our personnel in ETSB is for Clear Leadership and Clear Expectations. That begins with effective governance that provides such clarity. When expectations and objectives are clear, we can ask for commitment to our common goals and ambitions. With conscious deliberate commitment comes accountability for outcomes. We are confident that we can launch a process of effective governance that will infuse the ETSB with clarity of purpose, individual commitment and objective accountability. I want to thank the Commissioners for going above and beyond their regular

responsibilities to commit extra time to our fresh approach. We will be continuing to develop and refine our tools throughout the coming year.

As elected Commissioners, we have a long proud history of working for our Board. Long before a Ministry of Education was established in Quebec by the Government of Jean Lesage in 1964, community leaders came together to organize English education. With the consent of their communities they levied taxes, built schools, hired teachers and established curriculum. While French education in Quebec remained a responsibility of the Catholic Church until the 1960^s, English school commissioners were drawn from and accountable to the surrounding community and recognized as local leaders. In that vein, I am delighted to take this opportunity to congratulate Commissioner Joy Humenuik on her commitment, energy and continuing enthusiasm. At a ceremony in November recognizing employees who have attained 25 years of service to the Board, Joy was among those honoured. Such continuing devotion to public service deserves recognition and I trust members of this Council will join me once again to congratulate her.

Our other concerns and preoccupations remain. While Bill 40 was not adopted through closure last December as many expected, it remains the stated intention of the Government to abolish democratically elected school boards. We remain adamantly opposed to the intention and to the details of the Bill; removing the local component of governance would leave public education in the hands of distant bureaucrats who, history tells us, are customarily more interested in equality than in equity, more concerned over budgets than services and who are relatively insensitive to local variations in practice and culture. The latest form of the Bill does contain what appears to be a hastily improvised concession to allow English School Boards to retain some vestiges of local input, but it is clear that the overriding purpose is to place all decision-making in the hands of the Minister and the Ministry. It is not our jobs or our paltry stipends we are working to defend, but the ability to make decisions independent of centralized powers; decisions that keep small schools open in communities that operate open and welcoming schools as centres of activity for the English community and that cater to local priorities and student needs first.

I have recently represented the Board in a number of forums where I had opportunities to express opposition to Bill 40. The Quebec Secretariat for Anglophone Relations held regional and province-wide consultations with English community representatives. Many of our partners also participated and there were consistent expressions of opposition to abolition of school board democracy. I also was part of a delegation of four representatives of the English Public Schools that met with the Minister of Education Jean-Francois Roberge in Montreal in December to explain specific aspects of his Bill that we found unworkable. The Minister listened and appeared open to discussing modifications to his Bill, but since then, the promised meetings with his staff have not occurred. Last Friday, I participated in a press conference with representatives of municipalities, community groups and school boards to once again demonstrate the broad public opposition to the Bill. Meanwhile, clause-by-clause, study of the Bill continues by the Commission for Culture and Education. I took the opportunity to ask Christine Labrie, MLA for Sherbrooke who sits on that Commission about progress and she indicated that only a small fraction of the over 300 clauses have been addressed. There were media reports lately that the Minister appears to be becoming impatient and has started to accuse the opposition parties of filibustering to slow progress.

On a different front, 2020 is a year in which collective agreements for all parts of public education must be renegotiated. In December, I attended an extended briefing by the English Labour Relations Advisory Committee. These are our negotiators and we discussed key issues to be addressed in this round of negotiations. While salary and benefits are negotiated directly with Treasury Board and our negotiators have nothing to say about those terms, other issues that tend to receive far less media attention are important for effective management of public education. We were able to establish a number of positions that if adopted would facilitate managing our huge territory with our widely scattered small schools. I want to take a moment to acknowledge the outstanding efforts of Michel Soucy, our Interim Director General. He not only heads our internal management team but also participates in both the English Directors-General Table and our regional Estrie DG table and on all the related committees. He also answers to the Minister when called upon. It is an overwhelming complex task that he handles with grace and competence. I am delighted to work closely with him and I trust the efforts of our entire Council of Commissioners contribute in some way toward making ETSB function better.

One of Michel's many priorities is to restructure and streamline our services to adults. We have been, as many know, partners for over 40 years with the Commission Scolaire Val-des-Cerfs in Cowansville where we jointly operate a vocational training centre. More recently, we embarked in a joint venture with the three French Estrie School Boards to offer tailored training to employers. A manager, Jean-Michel Dupont, has been engaged to launch the Services Aux Entreprises Estrie and he reports encouraging progress in building an inventory of skilled trainers and representatives to address the needs of employers. The chronic shortage of labour that has emerged over the past year or two means more employers are looking to retrain existing employees because they cannot find new personnel with the skills they need. This means a culture shift is required in our adult services, particularly in Estrie, to adapt to the reality that courses as we traditionally offered them do not attract students, or if they do, the students leave before completing the course to accept job offers from eager employers. This situation is at the root of the substantial financial losses our adult services have suffered and continue to suffer. Only by restructuring and adopting a different culture can we turn the situation around. It is essential that we achieve improvement both to address our budget constraints and to better serve our potential clientele. The new joint service is among such changes that we plan to implement over the coming months.

In conclusion, change is in the air. I have mentioned only a couple of the most current issues that occupy our time and attention. We have many diverse challenges ahead of us that we are preparing to meet. ETSB has demonstrated its capacity to innovate and adapt over the past decades. I am confident that we will rise to the occasion again.

The Chair of the Audit Advisory Committee, Commissioner J. Humenuik, presented the following resolutions:

9.3.1 Finances:

9.3.1.1 Resolution No 20-01-45 <u>Organizational Framework for Managing the Risks of Corruption and Collusion in the Contract</u> Management Process

WHEREAS The Eastern Townships School Board (ETSB) is responsible for acquiring, in the most transparent, effective and efficient manner possible, the goods and services required to fulfil its mission;

WHEREAS the ETSB is committed to applying best practices in compliance to its internal Purchasing Policy and to governmental laws and policies applicable to the contract management process for public bodies;

WHEREAS on June 14, 2016, the *Conseil du trésor* adopted the *Directive Concernant la gestion des risques en matière de corruption et de collusion dans les processus de gestion contractuelle* (hereinafter, the "Directive");

WHEREAS the Directive came into effect on September 1, 2016, and was enacted under section 26 of the Act respecting contracting by public bodies (CQLR, c. C-65.1);

WHEREAS in accordance to the Directive, ETSB is required to adopt an organizational framework to manage the risks of corruption and collusion in the contract management process (hereinafter, the "*Organizational Framework*");

WHEREAS the ETSB must implement a corruption and collusion risk management plan for public contracts. The plan must include the organizational context, appraisal of the current situation, the desired situation establishing a risk mitigation measures plan, a follow-up monitoring & reviewing the measures implemented;

WHEREAS the Organizational Framework document is intended for all employees involved in the contract management process at the ETSB and applies to the contract management process for the purchase of goods and services and for construction projects, regardless of the nature and source of their funding;

IT WAS MOVED BY Commissioner J. Humenuik that this Framework comes into effect on the date of its adoption. IT WAS FURTHER MOVED that the Interim Director General and/or the Director of Finance be authorized to sign all associated documentation.

9.3.1.2 Resolution No 20-01-46 External Auditing Services for 2019-2020 to 2021-2022

WHEREAS section 286 of the Education Act requires that the financial activities of school boards be audited annually;

WHEREAS one (1) March audited financial statements every three years and one (1) June audited financial statements every year are required;

WHEREAS the external auditors for the Eastern Townships School Board (ETSB), Raymond Chabot Grant Thornton LLP (RCGT) mandate terminated on June 30, 2019;

WHEREAS Financial Services has placed a joint public call for tenders jointly with the *Commission scolaire des Sommets* and the *Commission scolaire des Hauts-Cantons* for external auditing services for the next three (3) years with the possibility of a two-year extension on a yearly basis;

WHEREAS three (3) bids were received by the Eastern Townships School Board;

WHEREAS the lowest bid was received by Raymond Chabot Grant Thornton (RCGT) in the amount of:

WHEREAS Raymond Chabot Grant Thornton (RCGT) has the required experience in auditing the education sector;

IT WAS MOVED BY Commissioner H. Turgeon, as recommended by the Executive Committee, to appoint Raymond Chabot Grant Thornton (RCGT) as external auditors for the 2019-2020, 2020-2021 and 2021-2022 school years.

9.3.2.1 Resolution No. E20-01-48 Sherbrooke Elementary School – Windows and exterior doors replacement

WHEREAS the *ministère de l'Éducation et de l'Enseignement supérieur (MEES) dedicated* a budget of \$728,576 for the project stated above, under the program *MDB - Maintien des bâtiments - Budget additionnel 2018-19 Mesure: 50625*;

WHEREAS the *ministère de l'Éducation et de l'Enseignement supérieur (MEES)* dedicated a budget of \$290,663 for the project stated above, under the program *MDB - Maintien des bâtiments 2017-18 Mesure: 50621*;

WHEREAS two (2) projects combined represents an overall budget of \$1,019,239;

WHEREAS three (3) companies retrieved the project specifications after a public invitation to bid on the project;

WHEREAS two (2) bids were received by the Eastern Townships School Board by the date and time specified;

WHEREAS the lowest bid in the amount of \$851,976 (excluding taxes), was received from the company *Construction Encore Ltée;*

WHEREAS after reviewing the bids, the assigned professional firm of *Firme ADSP*, has recommended the company *Construction Encore Ltée*, lowest bidder in conformity, to do the work;

WHEREAS the amount of the lowest bid from the contractor plus the professional fees and taxes is \$1,023,250;

IT WAS MOVED BY Commissioner F. MacGregor that the company *Construction Encore Ltée* be awarded the contract for the project stated above. **IT WAS FURTHER MOVED** that the Interim Director General and/or the Director of Material Resources be authorized to sign all associated documentation.

9.3.2.2 Resolution No. E20-01-49

Sutton Elementary School – Replacement of bus parking lot pavement and storm drainage systems

WHEREAS the *ministère de l'Éducation et de l'Enseignement supérieur (MEES)* approved a budget of \$416,329 for the project stated above, under the program *MDB - Maintien des bâtiments - Budget additionnel 2018-19 Mesure: 50625*;

WHEREAS thirteen (13) companies retrieved the project specifications after a public invitation to bid on the project;

WHEREAS seven (7) bids were received by the Eastern Townships School Board by the date and time specified;

WHEREAS the lowest bid in the amount of \$417,534 (excluding taxes), was received from the company *Excavation Désourdy inc.;*

WHEREAS after reviewing the bids, the assigned professional firm of *St-Georges Structures et Civil*, has recommended the company *Excavation Désourdy inc.*, lowest bidder in conformity, to do the work;

WHEREAS the amount of the lowest bid from the contractor plus the professional fees and taxes is \$518,134;

WHEREAS all additional funds required to complete the project, will be taken from *MDB* - *Maintien des bâtiments 2018- 19 program;*

IT WAS MOVED BY Commissioner R. Gagnon that the Company *Excavation Désourdy inc.* be awarded the contract for the project stated above. **IT WAS FURTHER MOVED** that the Interim Director General and/or the Director of Material Resources be authorized to sign all associated documentation.

9.3.2.3 Resolution No. E20-01-50 Delegation of Power

WHEREAS the Council of Commissioners has the authority on the points stated below;

WHEREAS the Council of Commissioners meeting occurs only once a month;

WHEREAS decisions often need to be taken in a timely manner;

WHEREAS the Eastern Townships School Board's (ETSB) investment budget has been increased significantly, thereby creating projects that involve bigger budgets to a point of requiring, by law, the involvement of a Selection Committee;

WHEREAS major projects imply the participation of a selection committee;

WHEREAS the Secréteriat du Conseil du Trésor has provided a list of twenty (20) functions that are allowed to be delegated in line with the Loi sur les Contrats des Organismes Publics (LCOP);

WHEREAS the ETSB requests a delegation of power to the Director General regarding the following functions:

- The nomination of the Selection Committee;
- Designation of the Secretary of the Selection Committee;
- Supervise the rotation of the members of the selection committee.

IT WAS MOVED BY Commissioner J. Humenuik that the functions stated above could be delegated to the Director General for the current calendar year and is subject to renewal.

9.3.2.4 Resolution No. E20-01-51 Servitude request for Hydro Quebec and Bell Canada

WHEREAS *Hydro-Québec* has requested a servitude (on behalf of *Hydro-Québec* and Bell Canada) on the Eastern Townships School Board's land near Alexander Galt Regional High School (lot #2 129 147);

WHEREAS the servitude is for the right to install posts, power lines (underground and/or aerial) and/or any other accessories related;

WHEREAS the servitude provides rights to public services and/or municipalities to access if needed;

WHEREAS the servitude provides the right to cut, trim or modify foliage if necessary;

WHEREAS the servitude touches two lands of an overall area of 75.4 square metres;

WHEREAS the servitude touches the ETSB's land of an area of 22.9 square metres;

WHEREAS the servitude will be valid for a period of 24 months;

IT WAS MOVED BY Commissioner G. Barnett that *Hydro-Québec* and Bell Canada be awarded the servitude requested for the land stated above. **IT WAS FURTHER MOVED** that the Interim Director General and/or the Director of Material Resources be authorized to sign all associated documentation.

Carried unanimously

9.4 Educational Advisory Committee

WHEREAS the Eastern Townships School Board has made modifications to its Criteria for the Enrolment of students for the 2020-2021 school year;

WHEREAS the Central Parents' Committee, the Educational Advisory subcommittee and the Management table have been consulted on these criteria;

IT WAS MOVED BY Commissioner M. E. Kirby that the Eastern Townships School Board approves the Criteria for Enrolment of students in school of the Eastern Townships School Board for the 2020-2021 school year (section 239 of the *Education Act*).

WHEREAS to maintain a dependable fleet and keep repair costs down, it is necessary to replace buses on a regular basis;

WHEREAS the *ministère de l'Éducation et de l'Enseignement supérieur* (MEES) has established parameters for the exchange of buses and has monies set aside for this purpose;

WHEREAS the Eastern Townships School Board has nine (9) buses which will meet these parameters by June 30th 2020, and therefore will need to be replaced;

IT WAS MOVED BY Commissioner H. Turgeon that the Eastern Townships School Board makes a request to the MEES to purchase nine (9) new buses in exchange for nine (9) used buses.

Carried unanimously

9.7.2 Resolution No. E20-01-XX Transportation Policy

It was suggested to postpone the discussion regarding the Transportation Policy, therefore this resolution was tabled. This matter will be discussed at a special meeting, February 13, 2020 in order to present the proposed Transportation Policy before the adoption of said policy.

15. <u>QUESTION PERIOD</u>

- M. Seline: Ms. Seline informed the Commissioners of some of the disparities in the negotiations such as the QPAT demands for lower ratios in Kindergarten and Grade One, plus more resources for students with special needs. The CPNCA is countering with an increase in class sizes for grades seven and eight as well as removing the priority rating. This can only set the tone for more ways to allow school boards to increase maximum class sizes and the number of guaranteed resources teachers. Is the Council of Commissioners aware of these demands?
- M. Murray: The short answer is no. The Council can express its wishes but all the requests must be rationalized by the team at the CPNCA. There are many areas under review and we cannot comment on them.
