#### 12. QESBA

M. Seline: Due to the current situation, have any parents and/or teachers contacted any commissioners

individually and if so what are their concerns?

A. McCrory: I have spoke with the administrators in my schools and the emergency daycares are going

well, especially Waterloo Elementary.

M. E. Kirby: The communication about the COVID-19 case at LVTC was well received. Evenn though for some parents, communications are difficult, they are glad for the individual teachers reaching out to students on Facebook and Facebook chat.

M. Seline: Have individual teachers or parents reached out to individual commissioners?

T. Bilodeau: Some have concerns that If there was a COVID-19 case declared at a school, how would parents find out and there was some concern about the case that was reported at ADS.

D. Brodie: I have spoken with parents who were concerned about the possible end of the school year

and whether the students will graduate. I referred parents to the MEES website and they

were relieved with the Minister's recent comments.

M. McCully: Is the ETSB working with the *Directeur de la Santé Publique* on what to do in order to provide

support to students with special needs?

E. Gaudet: The ETSB is working very closely with the *Directeur de la Santé Publique* on all health

related issue with COVID-19. We have not specifically addressed special needs students as we have to wait for what's coming from the MEES, but we will be working on it. There are resources for mental health on the pedagogical and complementary service's website and

we are reaching out to our complementary services professionals for extra help.

WHEREAS the ETSB also offers educational services at a distance to the adult clientele within the province;

WHEREAS the ETSB wishes to improve its offer of delivery service and reach out to the adult communities throughout the Eastern Townships Territory, including its more remote areas;

**WHEREAS** the ETSB wishes to promote collaboration and consolidate expertise among the personnel of its Adult General Education Centres;

**WHEREAS** the ETSB wishes to promote a sharing of resources within its Adult General Education Centres and create new opportunities for learning to the Adult English communities;

**WHEREAS** a resolution will be prepared at the Council of Commissioners meeting in May 2020 to present a new Deed of Establishment, including the name of this new entity;

**WHEREAS** the ETSB wishes to ensure a sectorial parity of representation in the composition of the Governing Board regarding this new entity;

WHEREAS the proposed merger was discussed in consultation with Commissioners at its Advisory Committees, as well as with all adult sector personnel and union representatives;

IT WAS MOVED BY Commissioner J. Humenuik to approve the merger of the ETSB's Adult Education Centres (Brome-Missisquoi Campus and New Horizons) and Distance Education, effective on July 1st 2020.

#### 8. <u>REPORTS</u>

#### 8.1 DIRECTOR GENERAL'S REPORT

The Interim Director General, Michel Soucy, reported that since our last council of Commissioners meeting, the Coronavirus COVID-19 has been declared a pandemic. Our provincial government has been quick and decisive in implementing measures to help stop the spread of the virus. One measure that has directly impacted the Eastern Townships School Board is the temporary closing of all schools as of Monday, March 16<sup>th</sup> until Friday, May 1<sup>st</sup> 2020. Yesterday, all businesses across Quebec, except for those that offer essential services, are to be closed for the next 3 weeks, which shows just how serious this is.

Although the closing of schools has been difficult for many parents and students, I would like to recognize our government, the Premier and his team for putting the safety of students and staff first. On Monday, March 16<sup>th</sup>, three ETSB daycares were opened at Heroes' in Cowansville, Parkview in Granby and Waterloo for the children of essential services personnel. We are fortunate to have some dedicated daycare educators, secretaries, caretakers and principals, who have really stepped up and kept these daycares open all week. In the coming days, our staff at these schools will need some time to recharge and I am confident that our ETSB community will answer the call to action to help out.

We realize that the closure of schools and daycares has caused a lot of stress for parents. I want to thank them for their collaboration and patience. We understand your concerns and that is why we have created a website where parents and students can access learning activities for now. The MEES is also preparing some online services and we need to coordinate our efforts to avoid confusion.

I also want to thank the head office, the schools and centre personnel for keeping our services up and running. Our administrators and teachers for their implications. I also want to say thank you to my colleagues on the DC who have worked hard (even before the school closures) to monitor the situation on a daily basis, coordinate with government agencies, and help to keep our personnel and parents informed.

We are all in this together and the most important message tonight is to follow the recommendations from Santé Publique, for social distancing, washing your hands, and self-isolating, if you are sick. Remember to reach by any way you can and especially those members of our community that are having a hard time dealing with the isolation. Help your neighbors and family members who cannot get out for groceries and basic needs. Be kind to each other; remember that everyone is concerned and feeling stressed right now. Together, we can make a difference.

#### 8.2 REPORT FROM THE CHAIR

The Chair of the Commissioners' Council, M. Murray, presented the report below:

Greetings from self-quarantine. I trust everyone is well and carefully observing all recommendations for physical distancing and social connecting.

I want to share with you my immense pride in the efforts of our entire ETSB team over the last dozen days. Despite the complete disruption of what we have, until now, considered normal and despite the real risk of falling into chaos; our leadership has risen to every challenge. I know our DG has spent inordinate amounts of time coping with the confusing and conflicting messaging from government and ministry. Apparently, meetings are called at any hour and quite often on weekends to issue instructions and directives. Completely unprecedented changes have been announced, such as the government suspension of collective agreements, that leadership is left to contend with. Despite some of our management team being required to self-quarantine because of possible exposure to contagion and all are required to respect physical distancing recommendations, everyone has carried on magnificently. Board services like payroll and accounts payable have been sustained to ensure that our personnel and our suppliers receive the funds they need at this critical juncture. HR is still operating to support personnel and begin planning for staffing next year while finding personnel for our three emergency daycares that support essential services workers. Our Facilities Management team is even accelerating the pace of activities to ensure schools will be safe and projects take advantage of this period without students or staff in the buildings. Above all, we depend absolutely on our communications thanks to our IT professionals who have kept us all connected.

Like you, I have seen the indications that our educators are taking initiative to connect with students and their families in many ways. There are videos online with greetings and often suggestions for constructive ways to use this time at home. Some school staffs have divided up the lists of students and contacted every household just to keep in touch. Our Pedagogical and Special Services teams have produced a website of learning activities that I feel certain will be appreciated. When I touched base with school administrators, they all expressed admiration and appreciation for the efforts of the central office team to keep them informed, to encourage solidarity and to provide support.

This is a time when we all must pull together to demonstrate that despite extraordinary stresses and disruptions, we can and will continue to perform our central obligations based on our pillars of pedagogical leadership, student engagement, professional learning community and attachment-based developmental approach.

I want to add an expression of my personal delight at the communiqué issued yesterday in which the minister of education announced that new material can be taught, although it will not be evaluated. This removes one of the principal barriers to getting back to educating in our new environment. I hope to see an explosion of fresh initiatives taking advantage of our deployment of computers to all students above cycle 2 and in earlier cycles that special needs students also have computers. We are equipped, capable and eager to demonstrate the best qualities of professional educators.

Congratulations again to everyone doing their share. I am sure I speak for all commissioners as well as the general public when I say we support you and endorse your efforts.

A meeting took place on March 11<sup>th</sup> 2020 regarding an animated discussion about Bill 40. There were many comments and questions. The next Parents' Committee meeting is scheduled on April 1<sup>st</sup> 2020 – hoping to hold it on line, if we can have something other than Google hangout.

#### 11. Student Advisory Committee

Commissioner J. Humenuik, representing the Student Advisory Committee, mentioned the following topics were discussed at the March 13, 2020, meeting:

A meeting took place at Alexander Galt Regional High School (AGRHS) on March 13, 2020. A tour of the school including Lennoxville Vocational Training Centre (LVTC) was done. The meeting took place on the same day the Premier announced that schools were suspended. The student members of this committee are curious and really motivated. They are going above and beyond their mandate.

A May meeting was planned with commissioners, but will have to wait and see. A zoom meeting should be considered and organized with students of this committee. M. Murray asked if CSAC could maybe hold meetings with ZOOM to make them more productive, more frequent and less travelling. J. Humenuik thought it was a good idea now that we have a tool that works well. We need a couple of meetings in person for them to get to know each other, but meeting on-line would give the members more time to meet.

The next Student Advisory Committee meeting is scheduled May 19, 2020.

#### 12. <u>QESBA</u>

- ✓ QESBA is still contesting in the courts in regards to Bill 40, but this has been put on hold due to the current circumstances;
- ✓ COVID-19 context: QESBA provided support to the MEES in order to contribute with learning tools that could be put on the MEES platform for supporting English clientele;

#### 13. COMMISSIONERS' COMMENTS AND QUESTIONS

Commissioner A. McCrory: Regarding the awards and the commissioner's bursary – we will be looking

into how to support this.

Commissioner C. Beaubien: Three elementary schools were contacted: Grades 5 and 6 students in her

area (North Hatley Elementary School, Ayer's Cliff Elementary School and Sunnyside Elementary School) brought their computers home. Grades 4 have school chrome books which can't be taken home. 20 to 25% of the parents of Sunnyside do not have internet access. At Ayer's Cliff

Elementary School, six parents do not have internet.

Commissioner M. Mercure: Are you working on contingency plans on how we will integrate the students

next year if this year is cancelled?

E. Lettner: Nothing can be compulsory this year – so next year, we will really have to

focus on the essentials to get up to speed. Our move towards formative

assessment will be essential.

Commissioner M. Mercure: Can we do on-line teaching?

E. Lettner: We have a good plan is in progress, but will wait in order to move ahead

with it to make sure we align with what the MEES is doing.

Commissioner M. Murray: It is our obligation to stay equitable with all our students, including the ones

who are struggling the most. Not all families have the same tools and

accessibility.

Commissioner R. Gagnon: We should take the salami approach – have to take small bites – maybe for

students who are going into advanced math next year, we can focus on

smaller groups.

Commissioner A. McCrory: I think that the three-core subjects should be taught and what they need to

leave high school, or be promoted to high school.

Commissioner J. Humenuik: People are stressed – we are still in the uncertain, panic mode; we must be

cautious about adding more onto people's plates that are already

overflowing.

# 16. **QUESTION PERIOD**

M. Seline: What will be the impact on student services in regards to the merger of Adult Education

services? Given the merger, will the offer be improved? With the merger, will there be an

impact on teachers?

M. Soucy: Services should be improved and there should not be a negative impact on teachers.

M. Seline: Given the COVID-19 pandemic, what will happen to the staffing plan?

J. Pauw: We are hoping that it will not impact the staffing plan and we are currently working with the

principals. The needs are being looked into for next year and for consultations, we will try

ZOOM meetings.

M. Seline: Are the standard deadlines being respected within the current context, especially staffing for

special needs students?

J. Pauw: Yes, we are working within the parameters.

M. Seline: Who do I contact in regards to these questions?

J. Pauw: You may go through me for your questions.

M. Seline: How are Governing Boards going to function?

E. Campbell: Governing Board meetings are public meetings. To hold meetings on line, this must be be

part of the internal rules of management. Deadlines will be difficult to meet. We are waiting

on the directives from the MEES.

M. Seline: What will happen with school-based activities – school council, TAC and special needs

committees, etc.?

J. Pauw: All noncritical meetings have been postponed – we are looking at how we can adjust for

these meetings.

M. Seline: To be clear, are you looking to reschedule?

J. Pauw: We are looking at our options, to be able to meet deadline and respect the process.

M. Murray: The Minister has said that arrangements will be made. Activities available now are on a voluntary basis because many do not involve technology to carry them out.

M. McCully: Could the record remind the school board that despite the closures, the school pages are still available?
