### 3. APPROVAL OF THE MINUTES OF THE MEETING OF JANUARY 26, 2021

Resolution No. ETSB 21-02-61 Approval of the Minutes of the Meeting of the Council of Commissioners held on January 26, 2021

WHEREAS a copy of the Minutes of the meeting of January 26, 2021 has been given to each Commissioner at least 6 hours before the opening of the meeting, the Secretary General is excused from reading the Minutes.

M. Seline: The Ministère de l'Éducation du Québec (MEQ) invested 20 million for ventilation. How much

does it represent for the Eastern Townships School Board (ETSB)?

E. Plante: Approximately \$114,000 for the ETSB.

M. Seline: Does cleaning of the ducts exceed the \$114,000?

E. Plante: No, approximately \$70,000.

M. Seline: What will be done with the rest of the money?

E. Plante: The rest will of the funds will be spent prudently on air quality issues.

### 5. RECOGNITION OF EXCELLENCE

 G. Barnett: During Hooked on School Days, the Lennoxville Vocational Training Centre (LVTC) awarded its Andrew Westover Perseverance Award this past week to Anna Driver, a student in the LPN course.

To quote LVTC, "Anna has always remained positive throughout the LPN course. Anna's positivity and motivation did not waiver. Through hard work and determination, she succeeded. We believe Anna is a great example of perseverance and positivity and deserving of recognition for her hard work and determination throughout the program."

The Andrew Westover Perseverance award was created by Andrea and Jason Westover in memory of their father who passed away December 28<sup>th</sup> 2013. The award recognizes those students who succeed and graduate in their program, despite having to face obstacles and or difficulties. ### 6. **BUSINESS ARISING**

The Secretary General, E. Campbell presented the following resolution:

## 6.1 Resolution No. ETSB 21-02-62 Waiver of rights for Stanstead land – Amended resolution

WHEREAS a Stanstead citizen has expressed an interest in acquiring a part of Lot 5,075,819 in Stanstead:

**WHEREAS** this Lot (Lot 5,075,819) is adjacent to Lot 5,075,820 on which Sunnyside Elementary School is built:

WHEREAS Lot 5,075,819 is now the property of Stanstead Wesleyan College;

**WHEREAS** Stanstead Wesleyan College is interested in disposing of this strip of land for the benefit of this citizen;

WHEREAS this strip of land with an area of 1,200.1m<sup>2</sup> shall be annexed to Lot 5,075,818 and shall not become a lot in itself;

**WHEREAS** the desired strip of land is an integral part of land that had previously been reserved for the seller for educational purposes only;

WHEREAS the lot to which the strip of land will be annexed to is located in a residential and commercial area;

WHEREAS by virtue of a right of first refusal conferred to the Protestant School Commission for the Municipality of the Village of Rock Island in the County of Stanstead, which has since become the Eastern Townships School Board in an act dating from 1950, the intervention of the School Board in this act of sale is required;

**WHEREAS** the School Board has expressed concern with the sale of a portion of Lot 5,075,819 identified as Lot 5,075,819-P;

IT IS MOVED BY Commissioner H. Turgeon that a real and free perpetual servitude prohibiting the cutting of healthy trees on a strip of land of 5 m wide along the northeastern limit of the part of the lot to be sold be granted (Lot 5 075 819-P) to the full depth versus Lot 5,075,820, is owned by the Eastern Townships School Board. In exchange, the School Board waives its right of first refusal so that the sale can be made.

IT WAS FURTHER MOVED that the Director General be authorized to sign any documentation relating to this transaction and that, in the absence of the Director General, the Secretary General may also sign.

Carried unanimously

### 7. NEW BUSINESS

The Secretary General, E. Campbell presented the Modified Deed of Establishment with the addition of Secondary 1 for the 2021-2022 school year:

### 7.1 <u>Waterloo Elementary School – Deed of Establishment – Modified</u>

The Assistant Director General, K. Mackey explained the process that the Waterloo Elementary School Governing Board has started before having a final decision.

A Commissioner inquired whether there are different standards between the East (territory of former Eastern Townships School Board) and the West (territory of the former District of Bedford School Board) concerning the presence of secondary one classes in elementary schools. The Chair replied that the option is available to all elementary schools and in a survery conducted several years ago, the governing boards each made a choice. For many years, Deeds of Establishment permitted all schools to opt to open secondary one classes, but so few did so the clause was removed except for existing classes. The matter was referred to the Governance and Ethics committee for a broader discussion of policy.

**IT WAS MOVED BY** Commissioner A. McCrory to modify the Waterloo Elementary School Deed of Establishment for the 2021-2022 school year.

### 8. REPORTS

### 8.1 <u>Director General's report</u>

The Director General, M. Soucy, reported the following:

To start my report this evening, let me take you back to our February 2020 Council meeting. For the most part, it was business as usual for the Eastern Townships School Board and we were preparing for the much anticipated annual March Break. Little did we know that in less than three weeks, business as usual would become a distant memory.

Since the World Health Organization (WHO) declared COVID-19 as a pandemic in March 2020, we have had to adapt to many new realities and ways of doing things. # 9.3.1.1 Resolution No. ETSB 21-02-63 <u>Authorization of signature – Addendum to the Fiber Optics Link</u> Construction and Operation Agreement Phase II

WHEREAS the *Commission scolaire du Val-des-Cerfs*, the Eastern Townships School Board, the *MRC de la Haute-Yamaska* and *Infrastructel Inc.* concluded an agreement for the construction and operation of a fibre optical network in 2002;

WHEREAS the *Commission scolaire du Val-des-Cerfs* was mandated to be the project general contractor for the construction of the fibre optical network;

WHEREAS the City of Cowansville acquired part of the fibre optical network that had been built on the City's territory directly from the *Commission scolaire du Val-des-Cerfs*, in conformity with the article 4.10 of the agreement signed in 2002;

WHEREAS the agreement between the City of Cowansville and the *Commission scolaire du Val-des-Cerfs*, came into effect on September 28, 2004 and, that it is and remains valid and in force to this day;

WHEREAS an addendum is proposed for the ratification of all decisions taken in connection with the participation of the City of Cowansville since September 28, 2004 in the agreement signed in 2002, and;

WHEREAS a second addendum was also proposed for the ratification of the acquisition of all rights, titles and interests of *Télécommuncations Xittel inc.* as of April 30, 2015 by *Maskatel LP*,

WHEREAS a third addendum is also proposed for the ratification of the acquisition of all rights, titles and interests of *Groupe Maskatel LP* by *Maskatel S.E.C.* on December 31, 2020;

WHEREAS all rights and obligations of the agreement signed in 2002, with respect to the construction, use, maintenance, repair, access, registration and disposal of the fibre optical network remain in effect;

**IT WAS MOVED BY** Commissioner J. Humenuik to authorize Mr. Michel Soucy, Director General, to sign all related documents, including all related addendums.

WHEREAS four (4) bids were received by the Eastern Townships School Board (ETSB) by the date and time specified;

WHEREAS the lowest bid in the amount of \$2,631,833 (excluding taxes), was received from the company *Construction Alain Morin Inc.*;

WHEREAS a performance grant of \$882,033 has been accepted by *Transition Énergétique Québec (TEQ)* and will be available to ETSB at the completion of the project;

WHEREAS after reviewing the bids, the assigned professional firm of *Un à Un Architecte* has recommended the company *Construction Alain Morin Inc.* the lowest bidder in conformity, to do the work for the amount of \$3,373,174 including taxes and professional fees;

WHEREAS all additional funds required to complete the project, will be taken from MDB - Maintien des bâtiments 2019-2020 Mesure: 50622 program;

WHEREAS the Eastern Townships School Board's (ETSB) International Student Program's (ISP) mission is to promote opportunities to expand our understanding of multicultural realities, thus promoting the development of global citizens;

**WHEREAS** a part of the mandate of the International Student Program is to increase student population within ETSB schools and centres;

WHEREAS in order to limit its financial risk and assure the success of its ISP, the ETSB is working with agents and agencies that offer support to both parties in the recruitment of students and the bridging of cultural and linguistic barriers;

WHEREAS the ETSB works within the regulatory frameworks established by Immigration Canada, *le Ministère de l'Immigration, Francisation et Intégration (Québec)*, and by the guidelines of the Canadian Association of Public Schools International, a non-profit organization comprised of 108 publicly-funded districts and *Éducation Internationale*, a non-profit cooperative funded by the *Ministère de l'Éducation (MEQ)*;

WHEREAS the ETSB cannot, on a yearly basis, project an exact number of international students recruited in its ISP, nor can it project which agency they will be recruited by;

WHEREAS a contractual agreement stipulates a percentage of the tuition fees to be paid to agents, on the basis of results;

WHEREAS the percentage for youth sector programs and for the adult programs is dictated by the global market for International Student Programs;

WHEREAS agent or agency fees for recruitment of international students are paid upon presentation of invoices following official student counts and which follows the usual commercial practice;

WHEREAS the following agent(s) presented invoices totaling an amount exceeding \$10,000:

•	Perfect International Cultural Exchange	\$13,500.00

Commissioner C. Beaubien: Lennoxville Vocational Training (LVTC):

Great website and Facebook update;

- They will focus to get more students in their programs instead of creating new programs;
- Within 1 or 2 years, the Centres de Formation Professionelle will be revamped by looking into the refinancing;
- Travail-étude will start on July 2<sup>nd</sup> for Shop and August 30<sup>th</sup> for Welding;
- Welding course will be offered to farmers (or anyone) for \$121, but could be paid by Service Quebec.

### **CLC Sunnyside**:

- Self-portrait workshops;
- Online mental health workshops for adults;
- Adult Education support;
- Used uniforms:
- Community involvement.

### QESBA Workshop on February 9, 2021:

- If they lose in April, they will appeal to the Supreme Court;

- They recommend the School Board election with the municipality election, and hopefully online voting, because of the size of our territory.

- Online workshops for adults Mental Health Workshop;

Commissioner F. MacGregor:

Attended an Alexander Galt Regional High School (AGRHS) Governing Board meeting. He saw the impact of fatigue on the personnel.

Commissioner J. Humenuik:

Asks that the Council recognizes the ones behind the school Facebook pages that shows us the reality of life in school.

Commissioner G. Barnett:

Attended the Eastern Townships Adult General Education (ETAGE) Governing Board meeting. Registrations were addressed as well as the *Pleins Rayons* program and COVID-19 cases:

They are running a deficit this year because of the online schedule and more language classes than expected. Of course, the current budget is based on ETPs from two years ago.

Student presence is important as adult exams haven't been waived as in the youth sector. Services at the two institutions are being redefined and clarified. They received adult and family literacy grants and programs in cooperation with Yamaska Literacy.

<u>Campus Brome Missisquoi (CBM)</u>: a social work position replaces the re-adaptation officer. ETAGE is presenting virtual workshops and videos on anxiety, working at home, burnouts, and other issues.

A new agreement has been concluded with *Plein Rayons* for ETSB students. Registration processes, advertising, websites are being reexamined to increase enrolment.

Bussing from the Granby area to CBM is a big issue with no spaces on buses.

<u>Lennoxville Elementary School (LES)</u>: The growing deficits regarding services such as the cafeteria are a big concern. Fundraising activities have been curtailed. LES will have a Pre-K next year.

<u>AGRHS</u>: They have had two COVID-19 cases; the second causing the group to quarantine. Getting enough masks is a challenge since the government is limiting them to two boxes per student. The 2 m distance can be maintained in the cafeteria but not in the halls, which may require a one-way circulation. Gyms are also closed.

<u>Homework</u>: Deadlines were discussed and teachers can be contacted regarding problems. Some 300 students were identified as needing tutoring and eleven teachers volunteered to participate. Subject priorities will be made especially for CEGEP requirements. Phelps Helps is very effective as is LEARN.

<u>MEES Exams</u>: There are no MEES exams this year, marks based on 35% for the first term and 65% for the second term. Some students do not like online learning.

<u>Debit & Credit cards</u>: Students and staff will soon be able to use debit and credit cards at the cafeteria with a 10-cent charge for a \$4 minimum purchase to cover card charges.

Lennoxville Vocational Training Centre (LVTC): They will try to start the HP welding next summer. Current focus is on enrolment. ATE will restart July 21 for machining, welding will restart August 31. A third IHCA (Institutional and Home Care Assistant) cohort has started. RAC may be applied to offer a DEP instead of an AEP so they can work anywhere, not only a CHSLD. There is confusion since there is no SAE agreement. An SAE welding course is being given at LVTC. SAE has been doing this *à la carte* but LVTC will do it so the students will receive an AEP.
