3. APPROVAL OF THE MINUTES OF THE MEETING OF NOVEMBER 23, 2021

Resolution No. ETSB 22-01-32

Approval of the Minutes of the Meeting of the Council of Commissioners held on November 23, 2021

WHEREAS a copy of the Minutes of the meeting of November 23, 2021 has been given to each Commissioner at least 6 hours before the opening of the meeting, the Secretary General is excused from reading the Minutes.

IT WAS MOVED BY Commissioner G. Barnett to excuse the Secretary General from reading the Minutes and to approve the Minutes of the meeting held on November 23, 2021 as modified:

9.3.1.4 WHEREAS the ETSB is implementing a three-year plan risk management plan on corruption and ...

WHEREAS the ETSB has assessed the first year of the action plan, reviewed the measures implemented and presented its results to the Audit Committee;

- **9.4.1** The phrase should have read WHEREAS the Eastern Townships School Board did not make modifications to **these** criteria for the enrolment of students for the 2022-2023 school year;

4. QUESTION PERIOD

M. Seline: Will the Eastern Townships School Board (ETSB) provide N95 masks and rapid tests for

teachers?

M. Murray: As of now, the Ministry did not ship nor provide any masks or rapid tests for teachers.

M. Seline: Will the ETSB reimburse the staff if employees buy some for themselves?

M. Murray: We will consider it and will get back to you.

M. Seline: I sent a letter to the Members of Parliament asking the them to create a tax exemption for

the education sector workers to pay for their "PPE" (Personal Protective Equipment) to feel safe. Seems to be an appropriate avenue to feel safe and that it doesn't impact their budget. Is it possible to reach out to the deputies and ask for compensation for teachers that must

buy their own PPE?

M. Murray: I would be happy to look into it at the next meeting, thank you for sending the letter to the

Secretary General please.

C. Rodrigue: Is it normal for a teacher to go at school to get tested and then circulate within the school

with a positive result?

M. Murray: I'm not sure what you are alluding to. It is normal to test at school if teachers are there. The

teacher probably felt it was important to have that closure with students, in saving goodbye.

More precautions should have been applied.

M. Seline: At the last Council meeting, the article in The Record indicated that Chair Mr. Murray and

the Board were in discussions with the unions. Is the Council aware that the union wasn't in discussion with the ETSB on this? Contrary to what was reported in The Record, does the

ETSB know that the union never met with the ETSB regarding the health of staff?

M. Murray: The ETSB received input on this matter from union members.

7.2 Resolution No. ETSB 22-01-33 Heroes' Memorial Elementary School – Appointment of Principal

WHEREAS the position of Principal 100% of the Heroes' Memorial Elementary School became vacant with the long-term leave of absence of Ms. Anne Stairs;

WHEREAS the position has been advertised throughout the Eastern Townships School Board (ETSB) territory through the internal posting procedures for the Eastern Townships Association of Administrators (ETAA) and to Management members;

WHEREAS the Selection Committee unanimously recommends Ms. Katrina Paxton to the Council of Commissioners;

WHEREAS a Commissioner's Sub-Committee was formed to meet with the candidate in view to share their appreciation to the Executive of the Council of Commissioners;

WHEREAS the candidate selected retains the qualifications and experience that respond to the criteria designated by the General Directorate;

WHEREAS the approved candidate will be subject to up to one-year probationary period and performance appraisal process;

IT WAS MOVED BY Commissioner J. Murray that the Council of Commissioners appoint Ms. Katrina Paxton, Principal of Heroes' Memorial Elementary School effective January 26, 2022.

8. REPORTS

8.1 <u>Director General's report</u>

The Director General, M. Soucy had nothing new to report.

8.2 Chair's report

The Chair of the Commissioners' Council, M. Murray, reported the following:

Yesterday the Minister of Education of Quebec, Jean-Francois Roberge, held a press conference to announce the grand success of the first week of reopening school buildings after the period of distance learning following the Christmas break. Also yesterday we sent a letter to all parents, one of the many communications over the past month, concerning the risk that we may need to cancel bus runs at short notice due to the absence of drivers. While untrained individuals can supervise a classroom of students, you will be reassured to learn that no unqualified drivers will be transporting children.

There has been little clarity in some of the communications and frequent changes of rules so I believe it is important to summarize our current situation. However, these conditions may change with little or no notice. You should understand that school boards are being given explicit instructions on how to function that are not all made public. Note that the Minister's press conference shed very little info on this.

Prevention of COVID-19 transmission in schools has effectively been abandoned. While students and staff are still required to wear masks there is no contact tracing, no isolation of contacts, no case tracking and no notification of parents when a case is confirmed in their child's school or class. There will henceforth be no announcement of outbreaks. Windows are to be opened to freshen air but the CO₂ detectors now partially deployed are not to be taken literally and measures of extreme concentrations are not to be made public. The Ministry prefers to average the data so that overnight lows will serve to offset daytime concentrations in published statistics. I am reminded of the old adage that figures don't lie but liars figure.

Schools are forbidden to close classes and school boards are forbidden to close schools. This measure allows the Minister to announce with great pride that there has been no breakdown of educational services. Moments later, the Minister admitted that in some cases parents have been asked to supervise classes while the teacher, sick with COVID-19, teaches the class from isolation via internet. Also, perhaps on the margin, he admitted some classes have been closed but not reported to him. Apparently, the Minister is not, perhaps never has been, concerned over the quality of education of our students as long as they attend school.

The government clearly is unconcerned for the health and well-being of school personnel, since their exposure to contagion and illness is assumed. There has been systematic refusal to provide high-quality N95 masks to staff or air exchangers for classes. The Minister even claimed that there are hundreds of air exchangers available to school boards upon request but that few requests have been received. ETSB did request air exchangers some time ago – told they will arrive any day now. School boards have been instructed to prepare lists of replacements for sick teachers, particularly by appealing to retired teachers to return but also transferring personnel and, yes, inviting parents to volunteer. In fact, many of our retired teachers are subbing and some have stepped forward. They were told that their pension wouldn't be affected and they will be paid at the highest level. Yesterday, he announced that pay for retirees who accept the call would be at top of scale and would not impact their pensions. ETSB is in the process of contacting retirees all the way back to 2015 to invite them to serve as spares.

The Minister went on to tell parents that they have no need for information on the number of cases in schools or whether their children have been exposed since they are required by law to send their children to school unless they are ill. Information on absenteeism is being collected but the Minister declined to reveal how many. Among the many confusing instructions issued by the Minister is for teachers to open windows to refresh classroom air, but to use discretion in cold weather. It is unclear whether a teacher should be more attentive to student comfort with the indoor temperature or to student health. Their own health mentioned previously is not an issue.

It is hardly surprising that amid such conflicted chaotic and rapidly changing orders, school staff are extremely stressed. The entire burden of student safety, health and security has been downloaded onto their shoulders. I can only ask for parents to be understanding and flexible. We have great people doing their utmost to serve your children in difficult circumstances with little appreciation or consideration from the authorities.

WHEREAS school boards should also establish the interest rate for other overdue receivables;

WHEREAS the interest rate per annum will be clearly identified on the tax bills and other invoices;

WHEREAS from July 2015 to June 2019, as per resolution ETSB15-05-147, the Eastern Townships School Board interest rate on overdue tax accounts and other overdue receivables was set at 15%:

WHEREAS according to Section 42 of the Act to establish a single school tax rate adopted on April 2019, the Minister must mention in the *Gazette Officielle*, the applicable interest rate;

WHEREAS the following interest rates were published annually in the *Gazette Officielle*:

2019-2020 7% 2020-2021 7% 2021-2022 5%

IT WAS MOVED BY Commissioner J. Humenuik that the Eastern Townships School Board adopts the prescribed rates on overdue tax accounts and other overdue receivables as per the rates published annually in the *Gazette Officielle*.

WHEREAS the *Ministère de l'Éducation (MEQ)* approved a budget of \$234,185 for the project stated above, under the program *RDE – Résorption du déficit d'entretien 2018-2019 Mesure:* 50626;

WHEREAS a company known today as *Comco Entrepreneur en Bâtiment* was awarded a contract in the amount of \$261,867 including professional fees and taxes, for the project stated above;

WHEREAS during the project some modifications for additional work needed to be done;

WHEREAS the total amount for the contract including all modification orders, additional work and professional fees (including taxes), adds up to \$285,827;

WHEREAS all additional funds required to complete the project, will be taken from *MDB - Maintien* des bâtiments 2020-2021 program;

IT WAS MOVED BY Commissioner H. Turgeon that the modification and/or additional work be awarded in order to complete the work for the project stated above; IT WAS FURTHER MOVED that the Director General and/or the Director of Material Resources be authorized to sign all associated documentation.

9.3.2.6 Resolution No. ETSB 21-01-41 Sherbrooke Elementary School – Kitchen and Cafeteria Renovation

WHEREAS the *Ministère de l'Éducation (MEQ)* approved a budget of \$604,274 for the project stated above, under the program *MDB - Maintien des bâtiments 2021-2022 Mesure: 50621;*

WHEREAS three (3) companies retrieved the project specifications after a public invitation to bid on the project;

WHEREAS three (3) bids were received by the Eastern Townships School Board by the date and time specified;

WHEREAS the lowest bid in the amount of \$489,794 (including taxes), was received from the company *Grondin Marois Inc.*;

WHEREAS after reviewing the bids, the company *Grondin Marois Inc.* is the lowest bidder in conformity, to do the work for the amount of \$542,970, including professional fees and taxes;

IT WAS MOVED BY Commissioner M. Mercure to proceed with the work for the project stated above; **IT WAS FURTHER MOVED** that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Material Resources can also sign.

9.3.2.7 Resolution No. ETSB 21-01-42 Clarenceville Elementary School – Building Sale

WHEREAS the Clarenceville Elementary School has been offered to public organizations with the intention of selling it;

WHEREAS the Town of *Saint-George de Clarenceville (TSGC)* has shown interest in acquiring the property;

WHEREAS the Société Québécoise des Infrastructures (SQI) have led the alienation process;

WHEREAS negotiations between the Eastern Townships School Board (ETSB) and the TSGC has led to a verbal agreement under condition of each other's council acceptance;

WHEREAS the ETSB accepts to assume the cost of the decontamination;

WHEREAS the TSGC accepts to assume the cost of the demolition;

WHEREAS once TSGC has passed a resolution to this effect and the agreement has been notarized, the ETSB accepts to sell the land for \$1;

IT WAS MOVED BY Commissioner M. Murray to allow the Eastern Townships School Board to alienate this asset complying with the procedure in place; IT WAS FURTHER MOVED that the Director General and/or the Director of Material Resources be authorized to sign all associated documentation.

9.3.2.8 Resolution No. ETSB 21-01-43 <u>Asbestos-Danville-Shipton, Sutton and Butler Elementary Schools – Playground Annual Project</u>

WHEREAS the Eastern Townships School Board (ETSB) offers a financial aid of \$75,000 in playground improvement for three schools every year. An equal amount of \$25,000 is available to each school's project;

WHEREAS for every playground improvement project, the ETSB will contribute to a maximum of \$25,000;

WHEREAS the *Ministère de l'Éducation du Québec* (MEQ) will contribute up to \$50,000 per school playground project;

WHEREAS the ETSB will offer this recurring financial participation of \$75,000 annually;

WHEREAS the ETSB will use the monies from its global envelope of the *RTB – Réfection et transformation des Bâtiments* program to assume its share of the project;

IT WAS MOVED BY Commissioner T. QESBA continues to battle against Bill 21 (secularizing law) with other applicants. QESBA also provided reactions regarding Bill 9 (Student Ombudsman) during the hearings.

Also Bill 9, the QESBA presented to the National Assembly – difficulty with the Ombudsman losing independence and no longer engaged directly by school boards. The complaint process will slow down response and create hoops to jump through in order to get a complaint attended to. Our position is that there should be a designated Ombudsman for the eight English School Boards in order to ensure English parents can address the Ombudsman in their own language.

M. Mercure: Did we get any decision regarding the Bill 40 challenge?

M. Murray: No, we are still in limbo. We are still waiting for a decision. We have been asked twice for

further clarification on the ETSB's position and were told that we might benefit from 24h advance notice when the decision is to go public. It is a constitutional case, which will very likely go to the Supreme Court. The judge may be proceeding cautiously because he is

conscious of the impacts of such a decision.

ATA President: Heidi Yetman remains dumbfounded by air quality in schools (quotes article in The

Record). What is the status of CO₂ sensors, ventilation, air purifiers at ETSB schools and centres? What is the ETSB's position regarding the installation of air

exchangers and CO₂ detectors in the schools?

M. Murray

ETSB Chair: We have asked for some air exchangers, but we are still waiting. CO₂ detectors

have already been installed in some of our schools. We can manage several schools in a week. The delay is in them arriving. The Minister says air exchangers are available upon request, which we have requested, but we still haven't received them. For ventilation, we consistently recommend to open windows and doors; assured by public health this will work. We have to rely on them (the authorities) seeing we're not health officials. Opening windows only needs to last a couple of

minutes to refresh and change the air.

WES Parent: Regarding graduation percentage rates > 30% of kids have IEPs (Individualized

Educational Plan), among them they have 3 to 4 times the non-graduation rate. What percentage of the boost or increase reported in the annual report reflects

these IEP students? What proportion of students with an (IEP) is part of the 5% difference in graduation rates compared with other English school boards?

ETSB Chair: That is a very involved question, but we can't answer on percentages.

Pedagogical Director: We are looking to reduce the gaps between different subgroups. We are working
