1. CALL THE MEETING TO ORDER

3. APPROVAL OF THE MINUTES OF THE MEETING OF MARCH 22, 2022

Resolution No. ETSB 22-04-55

<u>Approval of the Minutes of the Meeting of the Council of Commissioners held on March 22, 2022</u>

WHEREAS a copy of the Minutes of the meeting of March 22, 2022 has been given to each Commissioner at least 6 hours before the opening of the meeting, the Secretary General is excused from reading the Minutes.

IT WAS MOVED BY Commissioner G. Barnett to excuse the Secretary General from reading the Minutes and to approve the Minutes of the meeting held on March 22, 2022 as deposited.

4. **QUESTION PERIOD**

David Proulx: I rather not ask, but there was an incident where a substitute teacher without

a license swore, pushed or kicked a desk. We were told there was an investigation. My daughter was afraid to go to school. What should I tell her?

Kandy Mackey: An investigation has been done. Parents were communicated with. Any

details regarding a situation involving a staff member cannot be shared. I can assure you that an appropriate follow-up has been done in this dossier.

David Proulx: Are you telling me that the Grade 6 parents were communicated with after

the investigation?

Kandy Mackey: Parents concerned were communicated with by phone or by email.

Michael Murray: The teacher in question went into class the next morning and apologized

and the students mutually apologized. Afterward, the teacher said that after clearing the air, they had the best day. Sometimes, situations are difficult to control. This Grade 6 class is difficult to capture and keep their attention. It

has been reported that the class went better.

David Proulx: Out of desperation, a single mother sent a nasty letter to the school. She

received a letter back from the Eastern Townships School Board (ETSB) lawyer. Does the ETSB have a policy before sending a lawyer's letter to a

parent?

Michael Murray: There is no specific policy in this matter. Formal communications are

necessary if the informal communications have not had the desired results.

Annie Brasseur: I received a letter from you Mr. Murray regarding the Student Ombudsman.

What if the Student Ombudsman does not correctly fulfill or follow through with his mandate? What would it take to replace him? I heard that 2/3 of the Commissioners have to agree. What is my recourse? How do I go about

feeling good about the letter I received from the Board?

Michael Murray: The role of the Ombudsman is to make recommendations. When a

complaint has been registered with the school and has then gone through to the Board, then it's for the Ombudsman to investigate. He is an independent lawyer. The Council of Commissioners took the time to listen to you via in-camera session so you may speak freely. The School Board then met with administrators and explored the process followed. Your opinion is something that I cannot modify. The Student Ombudsman did an investigation and a decision was rendered, even if you do not accept it. An investigation was made in the Ombudsman's report to determine if the job was done and regarding the services your child receives (as a special needs

student). Due to your complaints, we made adjustments and charges have

been made for your child. We can only look to the future now and not the

past. Services are being delivered now.

David Proulx: In the sense of the law, people in positions of authority have to behave

according to higher standards. If the substitute teacher's behavior is acceptable because he apologized, does it mean that if I show up in the Principal's office swearing at her and flipping the desk, but then I apologized

afterwards, would that be acceptable?

Michael Murray: I would say it would be inappropriate. Teachers use different measures to

grab the attention of kids. The frustration had no place to go. Everyone works for the best outcomes. If we blow incidents up to crises, then all this energy is being spent dealing instead of investing this energy to improving

the school.

7. <u>NEW BUSINESS</u>

7.1 Resolution No. ETSB 22-04-56 By-Law 01 – Council of Commissioners meetings

WHEREAS the Eastern Townships School Board's (ETSB) Council of Commissioners is the principal body governing the School Board;

WHEREAS among the School Board's By-Laws, there are multiple By-Laws adopted at various times to establish dates and conditions for Council of Commissioners meetings, including By-Law 1, By-Law 9, By-Law 10, By-Law 12 and By-Law 16;

WHEREAS the different By-Laws are internally contradictory and confusing;

WHEREAS all Council of Commissioners meetings are public. The time and the location of meetings must be published in advance and prominently posted.

BE IT HEREBY RESOLVED:

- 1. To withdraw By-Laws 9, 10, 12 and 16 and remove them from the School Board's list of By-Laws.
- 2. To replace the By-Law 1 text with the following:
- Regular Council of Commissioners (the Council) meetings will be held on the *Fourth Tuesday* of each month of the school year at 7:00 pm and at the Eastern Townships School Board (ETSB) Administrative Building situated at 340, Saint-Jean-Bosco Street, Magog. (CQLR 162);
- The ETSB's Secretary General shall draft the schedule of the meetings to be adopted by resolution before June 30th and to be published in accordance with requirements for public notice;
- Extraordinary Council of Commissioners meetings may be convened by the Council's Chairperson or two (2) commissioners by a forty-eight hour (48h) notice sent by the Secretary General to each member of the Council. The Secretary General gives a forty-eight hour (48h) public notice as well.(CQLR 163);
- All Council meetings both regular and extraordinary are public meetings. (CQLR 167);
- The quorum required for a Council meeting will be a majority of its voting members. (CQLR 160);

Commissioners and the public may attend a Council meeting by any means that allows those participating in or attending the meeting to communicate directly with each other. A commissioner who participates in a meeting through such means is deemed to be present at the meeting and forms part of the quorum. At least one Commissioner and the Director General must be physically present at the meeting's published location. (CQLR 169);

IT WAS MOVED BY Commissioner H. Turgeon to adopt this version of the By-Law 01 for the Council of Commissioners meetings.

7.2 Resolution No. ETSB 22-04-57 By-Law 04 – Executive Committee meetings

WHEREAS among the School Board's By-Laws, there are multiple By-Laws adopted at various times to establish dates of the Executive Committee meetings, including By-Law 4, By-Law 7, By-Law 8, By-Law 11 and By-Law 15;

WHEREAS the different By-Laws are potentially confusing;

BE IT HEREBY RESOLVED:

- 1. To withdraw By-Laws 7, 8, 11 and 15 and remove them from the School Board's list of By-Laws;
- 2. To replace the By-Law 4 text with the following:
- Regular Eastern Townships School Board (ETSB) Executive Committee meetings will be held on the Fourth Tuesday of each month of the school year at 6:00 pm at the ETSB Administrative Building situated at 340, Saint-Jean-Bosco Street, Magog;
- Extraordinary Executive Committee meetings may be convened by the Chairperson or two (2) members of the Executive Committee by a forty-eight hour (48h) notice sent by the Secretary General to each member of the Executive Committee. The Secretary General gives a forty-eight hour (48h) public notice as well. (CQLR 163);
- Notice of extraordinary meetings must indicate the time, the date, the location and the purpose or topic of the meeting. Only such items may be considered at the meeting unless all the members of the Executive Committee are present and decide otherwise. (CQLR 164);
- The presence of a member constitutes a waiver of notice of the meeting unless they attend the meeting in order to object to holding the meeting. (CQLR 165);
- The quorum required for an Executive meeting will be a majority of its voting members. (CQLR 160);

Members of the Executive Committee may participate in a meeting by any means that allows those participating in or attending the meeting to communicate directly with each other. A member of the Executive Committee who participates in a meeting through such means is deemed to be present at the meeting and forms part of the quorum. At least one member of the Executive Committee and the Director General must be physically present at the meeting's location. (CQLR 169);

IT WAS MOVED BY Commissioner J. Humenuik to adopt this version of the By-Law 04 for the Executive Committee meetings.

7.3 Resolution No. ETSB 22-04-58 <u>Alexander Galt Regional High School – Project of dedicated trails and a multifunctional trail – Viewpoint</u>

WHEREAS citizens of the Viewpoint neighborhood are mobilized to develop a project to reach downtown Lennoxville by foot or by bike,

WHEREAS these citizens have presented a project to the Borough of Lennoxville that includes dedicated trails in the woods at the back of Alexander Galt Regional High School (AGRHS) and the Lennoxville Vocational Training Centre (LVTC). The project also includes a multifunctional trail that will go from the Viewpoint neighborhood to Bishops University, through the fields that actually belong to Agriculture Canada and to Bishops University as presented in the attached sketch;

WHEREAS an agreement will be signed by the Municipality of Sherbrooke, Agriculture Canada and Bishops University;

WHEREAS there is a heavy traffic flow on route 108 in front of AGRHS and LVTC;

WHEREAS there has always been a concern for the safety of AGRHS and LVTC students;

WHEREAS the AGRHS and LVTC building is isolated from downtown Lennoxville which is hazardous for walkers and bikers to safely make their way along route 108;

WHEREAS the project is still in the planning phase, but has already been identified as a priority by the Borough of Lennoxville;

WHEREAS the Alexander Galt Regional High School has been an open campus since 2015 and that AGRHS and LVTC students will benefit from this project;

IT WAS MOVED BY Commissioner G. Barnett to support the building of dedicated trails and of a multifunctional trail from the AGRHS and LVTC campus in order for their students and for the whole community to connect with the Borough of Lennoxville by safely walking or biking.

7.4 Resolution No. ETSB 22-04-59 Knowlton Academy – Appointment of Principal 100%

WHEREAS the position of Principal 100% of Knowlton Academy will become vacant with the retirement of Ms. Renalee Gore for the 2022-2023 school year;

WHEREAS this nomination is in conformity with the Eastern Townships School Board Local Management Policy;

WHEREAS the Selection Committee unanimously recommends Mr. Frederik Noirfalise to the Council of Commissioners;

WHEREAS a Commissioner's Sub-Committee was formed to meet with the candidate in view to share their appreciation to the Executive of the Council of Commissioners;

WHEREAS the candidate selected retains the qualifications and experience that respond to the criteria designated by the General Directorate;

IT WAS MOVED BY Commissioner R. Gagnon that the Council of Commissioners appoint Mr. Frédéric Noirfalise, Principal of Knowlton Academy effective July 1st 2022.

8. REPORTS

8.1 Director General's report

The Director General, M. Soucy had nothing new to report.

8.2 Chair's report

The Chair of the Commissioners' Council, M. Murray reported the following:

Public Education and Canadian society in general both face a new threat to our institutions including schools and public education. Social Media is undermining common civility and courtesy between and among people who should have common interests. Social media encourages special interest groups, fragmenting hitherto cohesive groups by encouraging users to speak to and listen to only those who share their opinion. The concept of free speech has become perverted to mean, in many cases, only freedom to agree and endorse. The ability to criticize virtually and the breakdown of genuine person-to-person relationships have undermined consensus and trust. Anyone who disagrees is perceived not only as an enemy but as motivated by malicious intentions.

This has become a serious issue in education undermining our ability to effectively socialize students; teach them the skills of open communication, thoughtful argument and civil discourse. Cowardly bullies stridently abuse teachers, educators and educational leaders from the safety of their keyboards. There is no compromise that will satisfy them. They hurl uninformed hostile and hurtful criticism without

restraint or consideration for the circumstances in which we all labor. It seems as if the pandemic has accentuated these tendencies which were already emerging before COVID-19.

At ETSB, hundreds of educators in all categories contribute their best efforts to making school a happy, positive, kind and a considerate place for students. Sadly, it takes only a few strident intemperate ignorant critics to use social media to raise a storm over the most trivial matters. Repeatedly teachers are accused of terrible acts presumably motivated by the most negative of intentions.

Enough! It is time to call a halt! An aggressive minority of parents are among the most active in this respect, accusing educators of inflicting serious trauma on students and harm to their education; but they are themselves damaging the mental health of their own children. It is all too easy with the click of a retweet or share key to repeat other people's public, uninformed and inaccurate accusations, without ever verifying their validity. Such critics carefully avoid acknowledging the challenges and difficulties under which educators work. These hostile negative parents raise the level of anxiety of their own children with their fake news, undermining the trust students have for teachers and casting doubt on the value of education. With little understanding of the reality, they sow discord and discontent ignoring all the wonderful positive and creative ways that schools are contributing to the welfare of the children in our care.

At some schools, ETSB has been accused of willfully undermining educational success because students have had multiple teachers this year. Hellooo! Anybody heard of the pandemic? Educators are front line workers, doing their jobs in the presence of dozens and sometimes hundreds of other individuals on a daily basis. They wear masks, disinfect and social distance but they are exposed to all the risks of becoming sick. They succumb, not only to COVID-19 but also to the stress of constant concern for their students, their families and themselves. Some care for elderly parents who are particularly vulnerable. In the inevitable cases when employees become ill the School Board provides the best substitute teachers and aides we can find. Some of them are not fully qualified for their temporary roles, yet the critics are quick to claim malicious intentions behind putting them into classrooms. In reality this is part of an effort to prevent closures that may mean far worse consequences for our students. When students are taught by multiple teachers in and out of a class; evaluation of learning and issuing essential report cards becomes complicated, yet the critics don't hesitate to accuse educators of fabricating and falsifying the results instead of assuming best efforts. It is more than enough! Our personnel merit respect and courtesy for all they do for students and indirectly for the families of those students. It is time for the parent's critics to join our mission to make education the best it can be, building on successes rather than tearing it down. Sometimes criticism may be justified but it should be civil and thoughtful. It wouldn't hurt to check facts before hurling accusations or starting rumors like one that circulated recently claiming we intend to close a school. It would be even better after checking the facts, to interact privately and confidentially with schools to avoid shattering the attachment so many students have for significant educators in their lives. Best of all would be to make genuine contributions of time, energy and creativity to help us make schools even better. The same energy used in hostility and negativity can be used to improve and upgrade. Our goal is and always will be to achieve the best possible outcomes for our students. Is that different from what any parent wants?

9.2 Governance and Ethics Committee

The Director General, M. Soucy read the following resolution:

9.2.1 Resolution No. ETSB 22-04-60 Services Québec Agreement with the Eastern Townships School Board

WHEREAS Services Québec is the government body that funds employability services and purchases services from the Eastern Townships School Board (ETSB);

WHEREAS Services Québec Estrie, which is responsible for public employment services on its territory, is seeking the expertise of the Eastern Townships Adult General Education (ETAGE) of the ETSB to diversify and complete its offer of services to respond to the English-speaking population of the Eastern Townships;

WHEREAS the ETAGE is committed to offering educational and complementary services to English-speaking people aged 16 and over living on its territory;

WHEREAS orientation and employability services are important part of the complementary services offered by ETAGE throughout the Eastern Townships, in both rural and urban areas;

WHEREAS the ETSB through its Adult General Education service, has been offering the employability services to English-speaking population, since 1997;

WHEREAS the ETAGE will receive an amount of approximately \$146,225 as compensation for all the services offered in orientation and employability to the English-speaking population of its territory;

WHEREAS this agreement will be effective for a period of one (1) year from July 1, 2022, to June 30, 2023;

IT WAS MOVED BY Commissioner R. Gagnon that the Centre Director, Mr. Steve Dunn or the Director General is authorized to sign all associated documentation with *Services Québec* to continue offering the employability services to English-speaking population.

Adopted unanimously

The Chair of the Governance and Ethics Committee, Commissioner R. Gagnon also mentioned the topics discussed at the April 19, 2022:

ATTENDU que la Commission Scolaire Eastern Townships a, en vertu de sa résolution numéro (ETSB 21-11-26) du (23 novembre 2021), institué un régime d'emprunts, valide jusqu'au 31 décembre 2022, lui permettant d'effectuer des emprunts par marge de crédit, auprès du ministre des Finances, à titre de responsable du Fonds de financement, pour financer ses projets d'investissement pour lesquels une subvention est accordée par le ministre de l'Éducation;

ATTENDU que conformément à l'article 83 de la Loi sur l'administration financière (RLRQ, chapitre A-6.001), la Commission Scolaire Eastern Townships a, dans le cadre du régime d'emprunts précité, délégué le pouvoir d'emprunt ou celui de conclure les transactions, ou d'en approuver les conditions et les modalités, à certains dirigeants qui doivent agir conjointement;

ATTENDU que l'article 83 de la Loi sur l'administration financière, modifié par l'article 56 de Loi concernant la mise en œuvre de certaines dispositions du discours sur le budget du 25 mars 2021 et modifiant d'autres dispositions (L.Q. 2022, c. 3), précise que, lorsqu'il s'agit d'effectuer un emprunt à court terme ou par marge de crédit, le pouvoir peut être exercé par un membre du personnel autorisé par l'organisme, pouvant agir seul;

ATTENDU qu'il y a lieu en conséquence de remplacer le 6^{ième} alinéa du dispositif de la résolution précitée afin de désigner les personnes autorisées à signer les confirmations de transaction nécessaires aux emprunts par marge de crédit;

EN CONSÉQUENCE, IL EST RÉSOLU:

- 1. 9.3.1.3 Resolution No. ETSB 22-04-63

Objectives and Principles Governing the Allocation of Resources pursuant to Section 275 Education Act (EA) and allocation of surpluses Section 193.4 (EA) – Budget Year 2022-2023

WHEREAS Section 275 of the EA states that after consulting with the governing boards and the parents' committee, and taking into account the recommendations of the resource allocation committee under the fourth paragraph of section 193.3, the school board shall establish objectives and principles governing the allocation of subsidies, school-tax proceeds and its other revenues;

WHEREAS under Section 193.4. (EA) the resource allocation committee must annually make a recommendation to the Council of Commissioners regarding the allocation of the surpluses of the School Board's educational institutions in accordance with section 96.24 (EA);

WHEREAS in accordance with Section 193.3. (EA), the resource allocation committee has set up a consultation process with a view to establishing objectives and principles governing the annual allocation of revenues in accordance with section 275, determining how those revenues are to be allocated in accordance with Section 275.1, including by setting out the criteria to be used to determine the amounts allocated, and determining how student services are to be distributed in accordance with Section 261;

WHEREAS under Section 193(9) (EA) the Central Parents' Committee was consulted on the objectives and principles governing the allocation of subsidies, school-tax proceeds and other revenues among educational institutions as well as the criteria pertaining thereto, and the objectives, principles and criteria used to determine the amount to be withheld by the school board for its needs and those of its committees;

IT WAS MOVED BY Commissioner D. Zigby that the Council of Commissioners approve the Objectives and Principles Governing the Allocation of Subsidies, School Tax proceeds and other Revenues, as well as the objectives, principles and criteria used to determine the amount reserved for its own needs and the needs of its committees, as it pertains to the School Board's budget for the 2022-2023 school year;

IT WAS FURTHER MOVED to accept that School/Centre surplus will be limited to whichever is greater, \$10,000 or 5% of the operating budget, excluding decentralized grants. Until Schools or Centres surpluses are within the predetermined range a School/Centre cannot increase its surplus and must in fact decrease the amount of its surplus to the predetermined range (\$10,000 or 5% of its original budget excluding the decentralized grants). Deficits are to be reimbursed at a maximum of 2% to 5% per year of the operating budget excluding decentralized grants for the school year 2022-2023.
