**WHEREAS** the position was advertised in September 2022, both externally and internally, following the Eastern Townships School Board (ETSB) internal posting procedures;

**WHEREAS** having completed the process, the Selection Committee unanimously recommends this person to the Council of Commissioners;

**WHEREAS** the candidate selected retains the qualifications and experience that respond to the criteria designated by the General Directorate;

**WHEREAS** the approved candidate will be subject to up to a one-year probationary period and performance appraisal process;

**IT WAS MOVED BY** Commissioner C. Beaubien that the Council of Commissioners appoint Ms. Caroline Dufresne, Director of Human Resources effective January 16, 2023.
