ATA President:	The ATA conducted its own survey of teacher members with regards to violence in schools and noted a 16% increase in physical assault over the

past year. Would ETSB commissioners want to collaborate in a response to the report's findings?

I am receptive to the proposal. We want everyone to feel safe in our schools and would want to address solutions to any violence, physical or otherwise.

#### Commissioner R. Gosselin:

The students of Ms. Newton's grade 4 class from Parkview Elementary put their creativity to work for the benefit of the Granby community.

Last year, the mayor of Quebec City asked children to create a « Generational Chair », that would serve as a reminder for elected representatives to make decisions that consider the needs of future generations. The project was carried out in different cities around the province with the help of an organization called « *Mères au Front* ».

When a parent presented the opportunity to Ms. Newton, she gladly jumped on board. Her wonderfully creative students did a fabulous job decorating the chair to the theme of nature with special emphasis on species found in and around Granby in the *Haute-Yamaska* region. A local biologist even joined the class to educate them on the kinds of fauna and insects existing in the area. From there, the students chose what species they wanted to represent on the chair.

On Monday, June 5<sup>th</sup>, Ms. Newton and a few students attended the city Council meeting and personally presented the chair. The City of Granby elected representatives were very happy to receive the gift and made a special permanent place for it at the director's table in Granby's City Hall. Ms. Newton found the project to be an incredibly enriching experience for her students as it merged the disciplines of art, biology, politics and more importantly, it demonstrated to them that they are valued citizens of the society; a society that must strive to protect its natural surroundings.

# The Community pours out Support for Massey-Vanier's Graduating Students!

**Commissioner R. Gagnon:** Some 50 graduating students from Massey-Vanier High School were showered with support from the community at the annual scholarship and bursaries awards night held on May 31<sup>st</sup> 2023. The Massey-Vanier Scholarship, Bursary Fund (MVSBF) was first established back in 1975 to provide financial support to students going on to pursue a post-secondary education and continue to do so still today.

Over \$122,000 was awarded to graduating students from community donors including businesses, lodges, foundations, individuals, memorial scholarships, service clubs and other groups. The donors set the criteria for their particular scholarship and/or bursary with students required to maintain an overall average of 60% or higher to qualify for a bursary and an average of 80% or higher to be eligible for a scholarship. Recipients may be recognized for their determination and perseverance, creative writing skills, choice of a vocation, talent and even community service rendered among other criteria established by the donor. It is quite a process to coordinate these awards that are taken on by the MVSBF committee that boasts 13 volunteers who work throughout the year to make this awards night a true success, not to mention all the volunteers who contribute behind the scenes!

We congratulate all the recipients this year, including Dannica Davies & Noah Sparling seen in the bottom photo having each earned a scholarship from the ETSB's Commissioners who proudly applaud our graduating students. ### 7.2 Resolution No. ETSB 23-06-91 Confirmation of the Head Office Administrative Structure – 2023-2024

**WHEREAS** section 134 of the Regulation respecting *Certain Conditions of Employment of Senior Staff of School Boards* and of the *Comité de Gestion de la Taxe Scolaire de l'Île de Montréal* states that the School Board must confirm the Head Office Administrative Structure, as it has been amended;

**WHEREAS** the Commissioners have reviewed the proposed Administrative Structure for the Head Office for the 2023-2024 school year during the Governance & Ethics meeting on June 13, 2023;

**WHEREAS** following the nomination of the new Assistant Director General that will retain her mandate as Director of Financial Services, it was recommended to create the position of "Assistant Director" in the Finance Department to the existing structure;

**WHEREAS** the Eastern Townships Association of Administrators (ETAA) has been consulted on the structure;

WHEREAS this administrative structure is to take effect July 1st 2023, unless otherwise specified;

**IT WAS MOVED BY** Commissioner <u>G. Holliday</u> that the Council of Commissioners approve the Head Office Administrative Structure for the 2023-2024 school year, effective July 1<sup>st</sup> 2023.

## 7.3 Resolution No. ETSB 23-06-92 <u>Confirmation of the Schools and Centres Administrative Structure – 2023-2024</u>

**WHEREAS** section 134 of the Regulation respecting *Certain Conditions of Employment of Senior Staff of School Boards and of the Comité de Gestion de la Taxe Scolaire de l'Île de Montréal* states that the School Board must confirm the Schools and Centres Administrative Structure as it is amended;

**WHEREAS** the Commissioners have reviewed the proposed Administrative Structure for the Schools and Centres during the Governance & Ethics Advisory Committee Meeting on June 13, 2023;

**WHEREAS** the Eastern Townships Association of Administrators (ETAA) has been duly consulted on the 2023-2024 structure;

WHEREAS this administrative structure is to take effect on July 1st 2023, unless otherwise specified;

**IT WAS MOVED BY** Commissioner <u>T. Pezzi-Bilodeau</u> that the Council of Commissioners approve the Schools and Centres Administrative Structure for the 2023-2024 school year, effective July 1<sup>st</sup> 2023.

### 7.4 Resolution No. ETSB 23-06-93 By-Law 14 – Examination of complaints on matters other than services rendered to students

**WHEREAS** with the implementation of the new Act respecting the National Student Ombudsman, each school board needs to develop its own By-Law with regards to the examination of complaints on matters other than services rendered to students;

**WHEREAS** the School Board has developed a By-Law on *Examination of complaints on matters other than services rendered to students* (B014);

**WHEREAS** the proposed By-Law 14 on *Examination of complaints on matters other than services rendered to students* was developed with the participation of the Governance and Ethics Committee;

**WHEREAS** the By-Law on *Examination of complaints on matters other than services rendered to students* was sent for consultation to the Parents' Committee, all Governing Boards and Management;

WHEREAS all received comments have been taken into consideration;

WHEREAS the final version of the By-Law 14 was presented to the Executive Committee;

WHEREAS this By-Law will come into effect on the day of publication of a public notice;

**WHEREAS** a true copy of the By-Law B014 will be sent to each Governing Board and to the parents' committee once adopted by the Council of Commissioners;

**IT WAS MOVED BY** Commissioner <u>H. Turgeon</u> that By-Law 14 – *Examination of complaints on matters other than services rendered to students* be adopted.

#### 7.5 Resolution No. ETSB 23-06-94 2023-2024 Insurance Renwal

**WHEREAS** articles 178 and 270 of the *Education Act* stipulate that a School Board may take out liability insurance, professional insurance and property insurance (equipment and vehicles);

**WHEREAS** the Eastern Townships School Board's (ETSB) current insurance plan comes to term on June 30, 2023;

**WHEREAS** the Council of Commissioners agreed to adhere to the *Union réciproque d'assurance scolaire du Québec (URASQ)* by resolution (ETSB-23-03-56) in March 2023 for the liability insurance;

**WHEREAS** since 2012-2013, the Council of Commissioners has authorized the participation of the ETSB in the *Regroupement des commissions scolaires et des centres de services scolaires de la Montérégie* and in the *Estrie en matières d'assurances*;

**WHEREAS** Regroupement des commissions scolaires et des centres de services scolaires de la *Montérégie* and in the *Estrie* will continue to go with call for tender for insurance to cover crime, equipment and the vehicles;

**WHEREAS** *BFL* Canada and Beneva (previously named La Capitale) respectively bid on specific guarantees to cover all the proposed guarantees by the Regroupement des commissions scolaires et des centres de services scolaires de la Montérégie and in the Estrie en matières d'assurances for 2023-2024;

**WHEREAS** the consultant firm *Gestion Turcot* & *Associés Inc.* has recommended the *BFL Canada* and *Beneva offers*;

**IT WAS MOVED BY** Commissioner <u>G. Holliday</u> to accept the *BFL Canada* and *Beneva* offers for the renewal of the insurance contract for crime, equipment and for the vehicles for the 2023-2024 school year.

#### 7.6 Resolution No. ETSB 23-06-95 <u>Assessment report on the Risk Management Plan Concerning the Risks of Corruption and</u> <u>Collusion in Contract Management Process</u>

**WHEREAS** The Eastern Townships School Board (ETSB) is responsible for acquiring, in the most transparent, effective and efficient manner possible with the ETSB's purchase policy and government requirements (laws, policies, rules, etc), the goods and services required to fulfil its mission;

**WHEREAS** on June 14, 2016, the *Conseil du trésor* adopted the *Directive Concernant la gestion des risques en matière de corruption et de collusion dans les processus de gestion contractuelle* (hereinafter, the "Directive");

**WHEREAS** the Directive came into effect on September 1, 2016 and was enacted under section 26 of the Act respecting contracting by public bodies (CQLR, c. C-65.1);

**WHEREAS** in accordance to the Directive, ETSB has adopted an organizational framework to manage the risks of corruption and collusion in the contract management process (hereinafter, the "Organizational Framework");

**WHEREAS** the ETSB is implementing a three-year plan risk management plan on corruption and collusion for public contracts. The plan includes the organizational context, appraisal of the current situation, the desired situation establishing a risk mitigation measures plan and a follow-up monitoring & reviewing the measures implemented;

**WHEREAS** the ETSB has assessed the three year action plan, reviewed the measures implemented and presented its results to the audit committee;

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> that the Assessment report on Risk Management Plan Concerning the Risks of Corruption and Collusion in Contract Management Processes be received as tabled.

Carried unanimously

#### 7.7 Resolution No. ETSB 23-06-96 <u>Organizational Framework for Managing Risks of Corruption and Collusion in the Contract</u> <u>Management Process</u>

**WHEREAS** The Eastern Townships School Board (ETSB) is responsible for acquiring, in the most transparent, effective and efficient manner possible, the goods and services required to fulfil its mission;

**WHEREAS** the ETSB is committed to applying best practices in compliance to its internal Purchasing Policy and to governmental laws and policies applicable to the contract management process for public bodies;

**WHEREAS** on June 14, 2016, the *Conseil du trésor* adopted the *Directive Concernant la gestion des risques en matière de corruption et de collusion dans les processus de gestion contractuelle* (hereinafter, the "Directive");

**WHEREAS** the Directive came into effect on September 1, 2016, and was enacted under section 26 of the Act respecting contracting by public bodies (CQLR, c. C-65.1);

**WHEREAS** in accordance to the Directive, ETSB is required to adopt an organizational framework to manage the risks of corruption and collusion in the contract management process (hereinafter, the "*Organizational Framework*");

**WHEREAS** the ETSB must implement a corruption and collusion risk management plan for public contracts. The plan must include the organizational context, appraisal of the current situation, the desired situation establishing a risk mitigation measures plan, a follow-up monitoring & reviewing the measures implemented;

**WHEREAS** the Organizational Framework document is intended for all employees involved in the contract management process at the ETSB and applies to the contract management process for the purchase of goods and services and for construction projects, regardless of the nature and source of their funding;

**IT WAS MOVED BY** Commissioner <u>J. Murray</u> that the Assessment report on Risk Management Plan Concerning the Risks of Corruption and Collusion in Contract Management Processes be received as tabled.

Carried unanimously

#### 7.8 Resolution No. ETSB 23-06-97 Contracts to Public Bodies – Annual Rendering of Accounts

**WHEREAS** on December 7, 2012, the National Assembly adopted Bill 1 – *Integrity in Public Contracts Act;* 

**WHEREAS** in accordance with this law, the Treasury Board decreed the *Directive concernant la reddition de comptes en gestion contractuelle des organismes publics* (hereinafter referred to as the « Directive »), which came into force on April 1, 2013 and applies particularly to school boards;

**WHEREAS** the Directive outlines all cases of rendering of accounts and standardizes the content and the type of information to be transmitted to the Secretariat of the Treasury Board;

**WHEREAS** the requirements provided under this directive are from the *Loi sur les contrats des organismes publics (LCOP)*, which aims to promote the rendering of accounts based on the accountability of chief executive officers of public bodies and on the appropriate use of public funds;

**WHEREAS** according to the requirements outlined in the Directive, the School Board is required to render an account of its contractual activities during the period from April 1, 2022 to March 31, 2023;

**WHEREAS** the Directive stipulates that the chief executive officer of the public body must attest, on an annual basis, to the reliability of the data and controls related to contracts by using the form presented at the Audit Advisory Committee on June 20, 2023;

**WHEREAS** at Eastern Townships School Board, the duties of the executive officer of the public body for which an account must be rendered rest with the Council of Commissioners;

**WHEREAS** the Council of Commissioners must render account for the authorizations it gave during the period from April 1, 2022 to March 31, 2023;

**WHEREAS** all contracting activities have been performed by the appropriate school board administrators and respecting the *LCOP* to the best of their judgment and abilities within the resources available;

**IT IS MOVED BY** Commissioner <u>F. MacGregor</u>, seconded by Commissioner <u>T. Pezzi-Bilodeau</u> that Eastern Townships School Board: **ADOPT** the declaration of the executive officer of the public body attesting to the reliability of the data and management controls as appended to this resolution, in accordance with the template proposed by the Secretariat of the Treasury Board:

- 1. "This declaration is made by the executive officer of the public body in a context where all contracting activities have been performed by the appropriate administrators while respecting the *LCOP* to the best of their judgment and abilities and within the limits of the resources available."
- AUTHORIZE the Chairman of the School Board to sign the declaration of the executive officer of the public body (appendix 3) and any other document required to respect the requirements of the rendering of accounts as provided for in the Directive;
- 3. **TRANSMIT**, no later than June 30, 2023 all the required documents to the Secretariat of the Treasury Board so as to respect the requirement to render account as stipulated in the Directive.

#### 7.9 Resolution No. ETSB 23-06-98 <u>Nomination of the contract rules compliance monitor – Act Respecting Contracting by</u> <u>Public Bodies</u>

**WHEREAS** the school board is a public body, covered by section 4 of the Act respecting contracting by public bodies (LCOP), using public funds to purchase goods, obtain services and have construction work carried out;

**WHEREAS** the government has therefore put in place a legislative and regulatory framework designed to establish standards for important aspects of the contract management process, as well as an administrative framework to determine internal rules in this area;

WHEREAS this framework consists of a law and regulations on public procurement;

WHEREAS the Act Respecting Contracting by Public Bodies is to determine the conditions applicable with regard to public contracts between a public body and a contractor who is a legal person established for a private interest, a general, limited or undeclared partnership or a natural person who operates a sole proprietorship;

**WHEREAS** the chief executive officer of a public body must designate a *contract rules compliance monitor*,

**WHEREAS** the functions of the contract rules compliance monitor include (1) seeing that measures are put in place within the public body to comply with the contract rules prescribed by this Act and the regulations, policies and directives under this Act; (2) advising, and making recommendations or providing advisory opinions to, the chief executive officer on compliance with contract rules; (3) seeing that measures are put in place within the public body to ensure the integrity of internal processes; (4) seeing to the professional fitness of the personnel involved in contract rules are complied with; any other function the chief executive officer may require to ensure that contract rules are complied with;

**WHEREAS** the position of *contract rules compliance monitor* of the Eastern Townships School Board will become vacant with the departure of Mr. Michel Soucy on June 30<sup>th</sup> 2023;

**WHEREAS** the candidate selected retains the qualifications and experience required for this responsibility;

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> that the Council of Commissioners appoint Ms. Sophie Leduc as the contract *rules compliance monitor* of the Eastern Townships School Board, effective July 1<sup>st</sup> 2023.

The following three resolutions were presented by the Chair of the Audit Committee, Commissioner J. Humenuik:

#### 7.10 Resolution No. ETSB 23-06-99 Approval of the Schools/Centres Budgets – 2023-2024

**WHEREAS** Section 276 of the *Education Act* states that every school board is responsible for approving the budgets of their schools, vocational training centres and adult education centre;

WHEREAS it is necessary to ratify the budgets;

**WHEREAS** the governing boards of all Schools and Centres have adopted their school/centre budgets for 2023-2024;

**WHEREAS** the schools/centres budgets for 2023-2024 have been presented and analyzed at the June 20, 2023 Audit Advisory Committee meeting;

**WHEREAS** the Audit committee recommends the ratification of the schools/centres budgets for 2023-2024;

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> that the Council of Commissioners ratify the budget of each school/centre for 2023-2024.

Carried unanimously

## 7.11 Resolution No. ETSB 23-06-100 Adoption of the Eastern Townships School Board Budget – 2023-2024

**WHEREAS** in accordance with the *Education Act* (chapter I-13.3), the Eastern Townships School Board must adopt and transmit the operating budget, the investment and the debt service to the Minister of Education for the school year 2023-2024;

WHEREAS this budget provides for a balanced budget;

**WHEREAS** the school tax proceeds in the amount of \$4,900,168 was determined taking into consideration:

- an adjusted standardized assessment of taxable real property of \$25,000 or less in the amount of \$16,563,082
- a number of 16,499 taxable properties over \$25,000, and:
- The assessment rate of 0.09730 per \$100 set by the Minister for the 2023-2024 school tax.

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> that the operating budget, the investment and the debt service providing revenues of \$116,519,670 and expenditures of \$116,519,670 be approved and forwarded to the Minister of Education.

Carried unanimously

## 7.12 Resolution No. ETSB 23-06-101 Interest Rate on Overdue Taxes and Other Overdue Receivables

**WHEREAS** Section 316 of the *Education Act* requires that school boards establish an interest rate on overdue school taxes;

WHEREAS school boards should also establish the interest rate for other overdue receivables;

WHEREAS the interest rate per annum will be clearly identified on the tax bills and other invoices;

**WHEREAS** according to Section 42 of the Act to establish a single school tax rate adopted in April of 2019, the Minister must mention in the *Gazette Officielle*, the applicable interest rate;

**WHEREAS** the 2023-2024 interest rate of 10% was published in the *Gazette Officielle* on June 14<sup>th</sup> 2023;

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> that the Eastern Townships School Board adopts the prescribed rate on overdue tax accounts and other overdue receivables as per the rates published annually in the *Gazette Officielle*.

Carried unanimously

## 8. <u>REPORTS</u>

## 8.1 <u>Director General's report</u>

The Director General, M. Soucy, redacted a goodbye letter, seeing as this is his last Council meeting:

Since the day we were born, time has always been our most precious asset. Now is the time for me to take some for myself and my loved ones.

Considering the amazing management team of leaders here at the ETSB, this is a great time for me to leave.

The English-speaking communities of the ETSB are blessed to have individuals who are so dedicated to the success of each of our students, who represent the future of our society.

Even after 5 years, I still have a certain impression of being an impostor, and I have recently figured out why.

It is because of the tremendous admiration and respect that I have for all ETSB personnel, especially for those who are close to the day-to-day lives of our students and directly connected to their success stories; big or small.

You work hard and don't always get the credit you deserve, with the sole objective to provide our young people with the tools they need to succeed on their journey; one that will continue after graduation.

To each of the Commissioners, thank you for your cooperation and for being there for fundamentally good reasons. I have been blessed to work closely with some of you and I have grown from it.

Mr. Murray, at no time would I have thought of trading you. When the going gets tough, the tough get going!

I would like to thank the entire team of Directors as well as their teams at the Board Office, without whom the last 5 years would not have been such a good experience. The challenges have been many and yet, we have overcome them.

Major thanks goes out to my executive secretary Angela Vaillancourt, who was there to guide me, especially at the beginning of my mandate.

Special thanks to my assistant director general, Kandy for what you have done for me and for what you are doing for the ETSB family.

To all colleagues, the community entrusts us every day with their most precious treasures by choice, be aware and keep up the good work...despite all the noise around you. You are making a difference.

Education creates value in our society and I have been very fortunate to have been involved in it for a chapter of my life... Thank you for the last 11 years.

## 8.2 Chair's report

The Chair of the Council of Commissioners, M. Murray, reported the following:

Education as an institution has not traditionally been very interested in what students think about the education they receive. Education ministries, school board commissioners, teachers, parents and administrators make all the decisions about what is good and desirable. The idea of asking young people about the purpose of education, their experience of it or their thoughts about how it might be improved have been considered naïve or idealistic. How can children have any idea about what is good for them? They are likely to make inconsequential suggestions.

The best way to understand how wrong those assumptions are is to listen to students who are given encouragement to express their thoughts in an unthreatening environment. Happily at ETSB, we have some far-sighted individuals like Joy Humenuik and Kandy Mackey who pioneered our own Student Advisory Committee that has been functioning for several years. Students meet several times a year to exchange thoughts and visit other schools. Annually, commissioners meet the members to discuss issues and questions raised by both groups. Last June, we held the latest iteration: discussions were serious and thought-provoking.

One important topic was preoccupying: how to help students feel fully bilingual and competent in their command of a second language when they lack the confidence to use their acquired skills. Marks on final exams in French for ETSB graduating classes average above 90 percent, yet students still report discomfort and hesitation when using the language. Many ideas were exchanged, some of which will

find their way into pedagogy. We agreed on the need to move past rote learning of irregular verbs to provide real-world experience in conversations and in work contexts. I have to believe, seeing the numbers of our graduates who function effectively in jobs requiring French that we teach an effective command of the language, but students are clear that we need to go further, to provide the kind of experiences and practice that will make them comfortable in realistic situations in their communities. This is all the more important now that restrictions imposed on CEGEPs by the CAQ government will direct more of our graduates into French post-secondary institutions.

Another clear indication of how students feel is to observe their choices. Last Friday, I attended the graduation ceremony at Alexander Galt Regional High School, I was struck by the number of students who proudly indicated their intention to further their education and enter a career path taking courses at *Le Centre de formation professional Quatre Saisons*. As the name indicates, instruction is entirely in French, yet many graduates felt confident enough in their mastery of French to embark on career training in that language. Similarly, graduates in our other secondary schools indicated they would study or train in French language CEGEPS or Professional Training Centres. It underlines not only the excellent quality of instruction in French being given but the high confidence by students that they will have no extraordinary difficulty succeeding in that language. I want to express congratulations on behalf of this Council to all the teachers and staff who contributed and continue to contribute to this highly satisfactory outcome for students placed in our care.

Students have a great deal to tell us about their education. We need to prioritize our listening stance in order to encourage more useful feedback from the students we are trying so hard to serve. Preparing them for a world that is in a permanent state of rapid change, a world that we educators can barely perceive and hardly understand is a challenge we need to meet, and students can help us become more effective. It is their world after all, and we need to give them the opportunity to craft it to meet their own needs. Students express their views in many ways. Dropouts are telling us that the education we offer is not what they need. ETSB has succeeded in reducing dropouts by half in the last decade or so, but we still lose over 15%; that is about one in every 6 students; before they graduate. The rising rate of homeschooling is a further indication that we are not meeting perceived needs. When we finally have the opportunity to listen, as with our Student Advisory Committee, we need to pay close attention. It is with enormous gratitude that I thank the students who served on that committee this year generously paying forward by proposing changes and improvements that are likely to impact future cohorts far more than themselves. It is truly selfless and indicates that our efforts to teach citizenship and social responsibility are also succeeding.

This year has been turbulent and challenging at times, with demonstrations, complaints dissected publicly in the media, bus driver strikes and other stressful incidents. It is very easy to focus on the negatives and lose sight of the overwhelming preponderance of positive outcomes for our students, which are, after all, the purpose of everything we do. As my final note to this academic year, I want to congratulate everyone in our organization for a job well done. I wish you a restful rejuvenating summer and for those retiring, I wish you a sincere thank you for all you contributed.

I would be remiss if I failed to make particular mention of the departure for retirement of our Director General, Michel Soucy. Michel has been at the helm of our board through five very exceptional years.

Despite a worldwide pandemic that imposed huge burdens on students, staff and leaders, he was a rock of stability and reassurance. Even the wildly impulsive, contradictory and irrational orders from a government that had no idea what to do failed to faze him. Despite having to carry a double burden during the absence of Kandy Mackey, his close colleague, he piloted us through the turbulence; always appearing to be calm and confident. Thank you, Michel, from the bottom of my heart. I wish you a long, satisfying retirement and hope you will continue to consider yourself a member of our ETSB family.

**WHEREAS** the Eastern Townships School Board (ETSB) is part of a call for tender with the *Centre d'acquisitions gouvernementales (CAG)* according to the ministry requirements;

**WHEREAS** the CAG was behind schedule for the acquisition mandate and was not made available until spring 2023;

**WHEREAS** equipment prices have risen substantially since the project was presented last autumn;

**WHEREAS** the total amount for the renewal project adds up to \$419,000, an increase of approximately 4.75%;

**WHEREAS** all additional funds required for the completion of the project will be sourced through government measures aimed at maintaining technological infrastructure (Measures 50793 and 50750);

**IT WAS MOVED BY** Commissioner <u>E. McKnight</u> that the modification be awarded in order to complete the project stated above; **IT WAS FURTHER MOVED** that the Director General or the Director of Instructional Technology and Pedagogical Services be authorized to sign all associated documentation.

#### 9.6 Human Resources Advisory Committee

The Director of Human Resources, C. Dufresne presented the following:

### 9.6.1 Resolution No. ETSB 23-06-118 Engagement of Megan Webster for Phase 2 of Coaching – Mentoring Program

**WHEREAS** the Eastern Townships School Board (ETSB) has completed its second year of a new mentoring program as a means of establishing a system of teacher learning;

**WHEREAS** the ETSB engaged a consultant, Megan Webster, PhD, who specializes in how to improve PD for teachers, to build capacity in nine instructional Coaches that were selected for this purpose;

**WHEREAS** the ETSB wishes to pursue to build capacity in the nine Instructional Coaches in September 2023;

**WHEREAS** the coaches will work with 20 novice teachers during the year with the goal to improve instructional quality in the classroom;

**WHEREAS** the Ministry of Education has dedicated funds for this purpose through *Mesures:* 15151 and 15153;

**WHEREAS** Megan Webster will also work jointly with the Human Resources and Pedagogical Services teams to build the ETSB's internal capacity to run its own preparation program for the ETSB Master Instructional Coaches;

**WHEREAS** the cost of Megan Webster's services amounts to \$35,880 + applicable taxes for 17 days of professional development for Master Teacher Coaches, Pedagogical Services Consultants and Principals;

**IT WAS MOVED BY** Commissioner <u>C. Beaubien</u> to authorize the Director General or the Director of Human Resources to sign any documentation related to the engagement of Megan Webster to support the ETSB for the 2023-2024 school year.

Carried unanimously

#### 9.7 <u>Transportation Advisory Committee</u>

The Chair of the Transportation Advisory Committee, Commissioner G. Holliday mentioned the following:

- The Autobus Yamaska strike in the western sector, affecting 278 students, has come to an end. ETSB has put together a compensation plan of roughly \$13/day per student for each day that transportation was unavailable. Cheques will be mailed to each student as a gesture of good faith and appreciation for parents making the sacrifices necessary to ensure education continued;
- A cheque will be issued in mid-July.
