7. <u>NEW BUSINESS</u>

The Secretary General, E. Campbell presented the 2022-2023 Student Ombudsman Annual Report:

7.1 2022-2023 Student Ombudsman Annual Report

As per Sections 22.2 and 242 of the Education Act, and the By-Law of the Eastern Townships School Board establishing the procedure for the examination of complaints from students or their parents, below is my annual report as Student Ombudsman for the period of July 1st 2022 to June 30th 2023.

During the above-mentioned period, I received fourteen complaints. In thirteen cases, the complainants had not exhausted the remedies provided for them according to the procedure for the examination of complaints; therefore, they were referred to the internal complaint procedure.

The remaining complaint raised numerous dissatisfactions, including amongst others: refusal to develop an Intervention Plan, refusal to develop an Individualized Education Plan in a timely fashion, failure in the ETSB's obligations for adapted transportation, denial of classroom instruction for months, etc. When I investigated the matter, the student had been attending school full-time for almost a month. An

Intervention Plan and an Individualized Education Plan were in force. Strategies used as part of the Intervention Plan were provided to me, with examples of tools currently used at school. Daily individual transportation was provided to the student. I therefore concluded that at the time of my investigation, ETSB and the school were fulfilling their duties under the Education Act and ETSB's Policy & Procedures Governing the Organization of Educational Services for Students with Special Needs – Youth Sector.

To my knowledge, no student was expelled due to acts of bullying or violence.

I have no recommendation to make with respect to measures required to prevent and stop bullying and violence, as complaints of this nature were properly managed internally.

WHEREAS the ETSB also surveyed community partners for their impressions on a number of areas and used the data when formulating its plan;

WHEREAS it was felt that a focused and pointed approach would best serve the students and communities of the ETSB to foster student success;

WHEREAS the proposed ETSB's Commitment-to-Success Plan reflects the deliberations, feedback and future directions that were prioritized by the working committee;

8.1 Director General's report

The Director General, K. Mackey reported the following:

Tonight marks a pivotal moment... we have adopted our 2023-2027 Commitment-to-Success Plan. This plan signifies a major milestone in the Eastern Townships School Board's journey, and as such, it will be the sole focus of my report.

The Commitment-to-Success Plan we have embraced has one overarching objective: to increase our 7-year cohort graduation and qualification rate from its current 77.5% to an impressive 82.5%. This goal reflects our unwavering commitment to the academic and personal development of each student within our communities. At the heart of this plan lie four key orientations:

Addressing the Vulnerability of Preschoolers: We recognize the importance of early intervention and support, ensuring that every child receives a strong foundation upon which they can build a successful educational journey.

Bilingualism – Nurturing Academic and Cultural Enrichment: Our dedication to bilingualism not only enriches our students' academic experiences but also strengthens their cultural awareness, fostering well-rounded individuals.

Valorize Transitions and Alternative Pathways: We acknowledge that the path to success is not always linear. By valuing transitions and alternative pathways, we provide diverse opportunities for students to thrive.

Maintain and Increase the Focus on the Wellbeing of Students and Staff: The wellbeing of our students and staff remains a cornerstone of our mission. A healthy and supportive environment is essential for fostering growth and success.

Our new mission, vision, and values will become the guiding lights of our organization:

Our Mission: The ETSB exists to provide its communities with a learning environment that promotes academic and personal development leading to the attainment of graduation or certification and opportunities to flourish and succeed.

Conference for English Education

A Fall conference for English education will take place at McGill University for Concordia's research network. Mr. Murray invited the Commissioners to attend.

Demonstrations from employees of the public sector

There was a large demonstration in Quebec City on Saturday, September 23, 2023 and smaller ones elsewhere showing dissatisfaction with union negotiations – English and French sector employer representatives are in no way familiar with the English system. Unions are in a position to strike before the end of October 2023.

QESBA – Legal Funds

QESBA has a positive balance to pursue legal defence contesting Bill 21 and Bill 40.

expressed the need to put more school pictures (classrooms, cafeteria, playgrounds) in order to attract and show students and

parents on what we have to offer.

Chair M. Murray: Leaving this task with our Communications Department asking to

see what we can do to enrich and market our schools.
