# 9.2 Governance and Ethics Committee

The Director General, K. Mackey presented the following resolution:

#### 9.2.1 Resolution No. ETSB 25-01-32 Application of Mansonville Elementary School to become an alternative school

**WHEREAS** the Eastern Townships School Board (ETSB) recognizes the importance of offering diverse educational options to meet the varying needs of students and promote a supportive and innovative learning environment;

**WHEREAS** the ETSB recognizes that MES has consistently demonstrated a commitment to continuous improvement, excellence in student achievement and fostering a positive school climate;

**WHEREAS** the ETSB believes that transforming MES into an alternative school will better serve their students by providing individualized instruction, more flexible learning opportunities and tailored approaches to education that address the unique needs of each student;

**WHEREAS** MES is committed to providing professional development opportunities for teachers, and a more inclusive educational environment for all students;

**WHEREAS** MES's Governing Board has been consulted and is committed to ensuring that the transition to an alternative school model is thoroughly planned, with its input as well as that of school personnel, parents and the wider school community;

**WHEREAS** the ETSB has reviewed the application requirements for becoming an alternative school and has determined that MES meets the criteria established by the *ministère de l'Éducation du Québec* (*MEQ*) for such a transformation;

**WHEREAS** the ETSB intends to submit a formal application to the *MEQ* to request the designation of MES as an alternative school, with the goal of fostering a more personalized and dynamic educational experience for all of their students;

#### 9.4 Educational Advisory Committee (ESAC)

The Director of Instructional Technology and Pedagogical Services, E. Lettner presented the following resolutions:

#### 9.4.1 Resolution No. ETSB 25-01-33 Cloud hosting contract with ITI

**WHEREAS** under decree 596-2020, the Ministry of Cybersécurité et du Numérique (*MCN*) requires public organizations to migrate local server infrastructures to cloud hosting solutions by December 31, 2025;

**WHEREAS** the *MCN* facilitates the acquisition of these services by enabling us to procure them from a panel of pre-approved suppliers, thereby circumventing the traditional tendering process;

WHEREAS our databases and administrative softwares are already hosted at *GRICS*;

WHEREAS a hosting service is required for the rest of our infrastructure;

**WHEREAS** ITI has submitted a proposal for services in the amount of \$68,604 before taxes renewable annually;

**WHEREAS** the Eastern Townships School Board deems the offer to be advantageous, given its competitive pricing, the company's established reputation and the comprehensive support services available;

**WHEREAS** Measure 30181 (volet 2) dedicated to cloud services fully covers the costs associated with hosting our infrastructure;

**IT WAS MOVED BY** Commissioner <u>J. Murray</u> to authorize the Director General to sign any documents related to the acquisition of hosting services with ITI, up to a maximum amount of \$68,604 renewable annually, effective immediately;

**IT WAS FURTHER MOVED** that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Instructional Technology and Pedagogical Services can also sign.

#### 9.4.2 Resolution No. ETSB 25-01-34 Microsoft licenses acquisition 2025-2028

**WHEREAS** the ETSB would benefit from joining the Microsoft licenses purchasing group offered by the *Centre d'acquisitions gouvernementales (CAG)* over a 3-year period (2025-2028);

WHEREAS licensing needs were assessed over a three-year period;

WHEREAS Microsoft licenses are required to operate the various services hosted on our servers;

WHEREAS Microsoft licenses are required for our users (Office 365, Teams, Exchange Online, etc.);

**WHEREAS** Microsoft licenses are required to implement new government-required security rules that target public organizations and put in place by the "*Centre opérationnel en cyberdéfense*" (*COCD*);

WHEREAS all purchases will be done according to the *ETSB Purchase policy* and government requirements;

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> to authorize the Director General to sign any documentation related to the acquisition of Microsoft licenses, up to an amount of \$180,000 for 2025-2028 effective immediately;

**IT WAS FURTHER MOVED** that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Instructional Technology and Pedagogical Services can also sign.

Carried unanimously

#### 9.6.1 Resolution No ETSB 25-01-35 Employee assistance program and telemedicine services for employees

WHEREAS wellbeing is one of the values of the Eastern Townships School Board's (ETSB) Commitment-to-Success Plan;

WHEREAS the ETSB has been offering an employee assistance program for many years;

WHEREAS the ETSB aims to expand its support to employees by offering telemedicine services;

**WHEREAS** the *Centre d'acquisitions gouvernementales* (*CAG*) initiated a 3-year (with a 2-year extension option) mandate in 2023 for these two services;

WHEREAS the CAG has denied the ETSB's request to join the grouping under the current mandate;

**WHEREAS** the estimated cost of providing both an employee assistance program and telemedicine services to the ETSB employees is approximately \$90,000 per year;

**WHEREAS** the ETSB intends to pursue its own contract for these services until it can join the next *CAG* mandate;

**IT WAS MOVED BY** Commissioner <u>J. Humenuik</u> to proceed with a call for tender for employee assistance program and telemedicine services; **IT WAS FURTHER MOVED** that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Human Resources can also sign.

Carried unanimously

WHEREAS the Eastern Townships School Board owns and operates a fleet of school buses;

WHEREAS to maintain a dependable fleet and keep repair costs down, it is necessary to replace buses on a regular basis;

**WHEREAS** the *ministère de l'Éducation du Québec (MEQ)* has established parameters for the exchange of buses and has monies for this purpose;

WHEREAS the Eastern Townships School Board has fourteen (14) buses which will meet these parameters by June 30<sup>th</sup> 2025, and therefore will need to be replaced;

**IT WAS MOVED BY** Commissioner <u>H. Turgeon</u> that the Eastern Townships School Board make a request to the *MEQ* to purchase fourteen (14) new Electric buses.

Commitment-to-Success Plan: The students were excited to engage and give their opinions; it was an intellectual and collective engagement.

January 15, 2025, there was an online meeting regarding the school survey and the students' take on the information. Elementary students are stating topics to come.

# 12. <u>QESBA</u>

Bill 21 Challenge – Launched by Eastern Montreal School Board (EMSB), which has reached a critical point. The Supreme Court of Canada will declare an appeal to the judgment. It is now a question of if they will hear the case. Hopefully, we will have good news soon.

Budget compressions: Commissioners are trying to determine how to assist some school boards to reduce inperson Professional Development (PD) activities and transfer towards online PD to reduce travel costs. PD will be mostly online only for 2025-2026. The priority is placed on the Spring Conference.

# Massey-Vanier High School (MVHS)

Staff meeting: On December 9, 2024, I met and mingled with the staff. I also had the pleasure of receiving a MVHS mug as a gift.

# Campus Brome-Missisquoi (CBM) - Adult Education GB meeting

Meeting was held on December 18, 2024.

Despite their challenges, Director Steve Dunn and teachers remain optimistic about the results; oriented and proactive.

<u>New Service</u>: *Accompaniement en emploi*.

<u>Student participation</u>: Students are active members in the Centre and like to participate at Governing Boards. Activities included a winery visit, a cellphone challenge, workshops and a Christmas party.

<u>Concerns</u>: Some concerns regard bathrooms, lack of a microwave and empty vending machines. The Director assured them that he would look into these issues.

# Eastern Townships Adult General Education (ETAGE) Governing Board (GB)

<u>Educational Project</u>: The ETAGE Educational Project was presented, many inside and outside people have been involved, went through several revisions, includes the purpose, legal framework, process, groups involved, targets, objectives, success plan, ETAGE challenges and the follow-up.

<u>Francization</u>: After the financial and course termination effective November 25, 2024, ETAGE created and expanded their Socio-Vocational Instruction courses in a bilingual format to accommodate the Francization students. Social Vocational Integration (SVI) concerns the workforce, getting a job, serving business, is stable

Commissioner G. Barnett:

while Francization was unstable. Furthermore, ETAGE can offer Francization exams and if students get to L4, the citizenship exam can be offered, but ETAGE has lost most of the 400 plus students and most of the twenty plus teachers.

# Statistics:

- At 50% of the year, the 5 Exam Services categories are at half to two thirds of last years' figures;
- Online Education is at 36 versus 25 last year;
- With Schedule: SVI Francization;
- **O** New Horizons/CBM is at 54 with an expected increase;
- English New Horizons/CBM is at 112 vs 113;
- New Horizons Fall is at 119 vs 105;
- CBM Fall is at 72 vs 72;
- ETAGE SVI is at 43 vs 38;
- **O** DE is at 181 vs 94;
- LVTC Carpentry is at 20 vs 33;
- Other: Home Study with Schedule is at 35 vs 52;
- DES is at 4 vs 20;
- O Job Links (%): Orientation Guidance 43;
- **O** Job Search Assistance 86;
- Specialized Services 65;
- School Retention 17;
- **O** Employment Accompaniment.

<u>Budget</u>: With the imposition of the Francization cuts forced on ETAGE, the budget was drastically changed resulting in a \$280K budget deficit. However, this is expected to be mitigated in a year or two by Grants, Francization request, exterior services, Distance Education, 480 ETPs last year vs 150 in the past.

<u>Students</u>: They have been busy with a community fair, winery visit, workshops, Christmas party, potluck and other activities. CBM students reported numerous problems: Non-functional bathrooms, cleanliness, not enough microwaves and empty vending machines.

<u>Staff</u>: Exams, ETAGE Day, Student teachers, Christmas, career choice program, workshops, Job search, Al workshop, replacement of Maude Danis-Coulombe and resulting teamwork, offering services differently.

# <u>Alexander Galt Regional High School (AGRHS) Governing Board –</u> January 14, 2025

<u>15+</u>: This Sec 3 program targets students with a higher risk of not completing their high school leaving but have an interest in vocational education subjects.
