**PUBLIC NOTICE** is, hereby given to electors of the **Eastern Townships School Board (ETSB)**:

The following position is open for nominations:

- **One (1) commissioner**

Electoral Ward #3 - **Composed of the following municipalities:** Abercorn, Brome, Brome Lake and Sutton.

*May be elected to the above position, anyone who, on polling day :*

- ✓ Is entitled to have his/her name on the ETSB list of electors
- ✓ Has been domiciled on the ETSB territory for six (6) months or more.

Nomination papers for this position must be filed on the following days, times and locations

If more than one candidate files nomination papers for the **same position**, an election will be held on **July 13, 2025** from 10 AM to 8 PM and an advance poll will be held on **July 6, 2025** from 12 PM to 8 PM.

A revision period of the electoral list will be held on **June 16, 2025** (from 12 PM – 6 PM) and also on **June 24, 2025** (from 7 PM to 10 PM) at the Knowlton Academy Elementary School located at 81, Victoria Street in Knowlton, if this electoral ward is up for election.

An elector who has no child admitted to educational services provided in a French *centre de services scolaires* or in an English school board which covers their home address may choose to exercise **or** revoke their right to vote at an English language school board. This choice is made by sending a signed "Notice of option or revocation" (available online – see link below) to the Returning Officer of the ETSB **at the latest June 24, 2025 (10 PM)**.

I nominate to act as Election Clerk, *Mrs. Angela Vaillancourt*, as well as nominate her as an assistant authorized to receive nomination papers.
