# 7.2 Resolution No. ETSB 25-03-47 Request for authorization for vocational training program — General Building Maintenance 5711

WHEREAS the Eastern Townships School Board (ETSB) aims to diversify its vocational training services to the English-speaking community on its territory;

WHEREAS the ETSB wishes to enhance its offer of vocational training programs with the addition of General Building Maintenance (5711);

**WHEREAS** according to "Service Québec", the professional outlook for this type of job is favourable and a regional opinion will have to be issued for each program of study requested;

**WHEREAS** this program could be offered by the ETSB in partnership with other English school boards on a temporary or permanent basis;

**WHEREAS** the ETSB must respect the process established by the *ministère de l'Éducation du Québec* (*MEQ*);

WHEREAS the ETSB must apply for new programs and the application has been approved by the Provincial Organization of Continuing Education Directors, English (PROCEDE) and the English Language Vocational Educators Council (ELVEC) committee;

**WHEREAS** the ETSB must request authorization from the *MEQ* to offer these programs in its vocational training centres;

**IT WAS MOVED BY** Commissioner M. E. Kirby that the Eastern Townships School Board officially send a request to the MEQ for authorization to add General Building Maintenance (5711) to its vocational training program offer.

# 9.3.2.1 Resolution No. ETSB 25-03-49 New Horizons — Basement classrooms reorganization

WHEREAS the *ministère de l'Éducation (MEQ)* approved a budget of \$310,000 for the project stated above, under the program *MDB – Maintien des bâtiments 2023-2024 Mesure: 50621*;

WHEREAS seven (7) companies retrieved the project specifications after a public invitation to bid on the project;

WHEREAS five (5) bids were received by the Eastern Townships School Board (ETSB) by the date and time specified;

**WHEREAS** the lowest bid in the amount of \$226,203 (excluding taxes), was received from the company *Desrochers Bernard inc.*;

**WHEREAS** after reviewing the bids, the assigned professional firm of *Caraballo Architecture inc.* has recommended the company *Desrochers Bernard inc.* the lowest bidder in conformity, to do the work for the amount of \$332,007 including taxes and professional fees;

**WHEREAS** all additional funds required to complete the project, will be taken from *MDB – Maintien des bâtiments 2023-2024 Mesure: 50621*;

IT WAS MOVED BY Commissioner <u>Jody Murray</u> to proceed with the work for the project stated above;

IT WAS FURTHER MOVED that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Material Resources can also sign.

# 9.3.2.2 Resolution No. ETSB 25-03-50 Sherbrooke Elementary School – South staircase up to code and administrative sector

WHEREAS the *ministère de l'Éducation (MEQ)* approved a budget of \$1,022,617 for the project stated above, under the program *MDB - Maintien des bâtiments 2021–2022 Mesure: 50621*;

**WHEREAS** the *ministère de l'Éducation (MEQ)* approved a budget of \$600,000 for the project stated above, under the program *RDE – Résorption du déficit 2022-2023 Mesure: 50622*;

**WHEREAS** a company known today as *Grondin Marois inc.* was awarded a contract in the amount of \$946,451.63 including professional fees and taxes, for the project stated above;

WHEREAS during the project, some modifications for additional work needed to be done:

WHEREAS the amount of \$189,809 (20%) to pay for all modification orders, additional work and professional fees (including taxes), is required to finish the project;

WHEREAS the total amount for the contract, including all modification orders, additional work, and professional fees (including taxes), adds up to \$1,136,261;

IT WAS MOVED BY Commissioner H. Turgeon that the modification and/or additional work be awarded in order to complete the work for the project stated above;

IT WAS FURTHER MOVED that the Director General and/or the Director of Material Resources be authorized to sign all associated documentation.

# 9.3.2.3 Resolution No. ETSB 25-03-51 <u>Princess Elizabeth Elementary School – Kitchen Renovation</u>

**WHEREAS** the *ministère de l'Éducation (MEQ)* approved a budget of \$441,585 for the project stated above, under the program *RDE – Résorption du déficit 2021-2022 Mesure: 50622*;

WHEREAS the *ministère de l'Éducation (MEQ)* approved a budget of \$400,000 for the project stated above, under the program MDB – Maintien des bâtiments 2023-2024 Mesure: 50621;

WHEREAS three (3) companies retrieved the project specifications after a public invitation to bid on the project;

WHEREAS three (3) bids were received by the Eastern Townships School Board (ETSB) by the date and time specified;

**WHEREAS** the lowest bid in the amount of \$343,345 (excluding taxes), was received from the company *Construction Sylvatech Inc.*;

**WHEREAS** after reviewing the bids, the assigned professional firm of *ADSP Architecture + Design* has recommended the company *Construction Sylvatech Inc.*, the lowest bidder in conformity, to do the work for the amount of \$566,410 including taxes and professional fees;

IT WAS MOVED BY Commissioner H. Turgeon to proceed with the work for the project stated above;

**IT WAS FURTHER MOVED** that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Material Resources can also sign.

# 9.3.2.4 Resolution No. ETSB 25-03-52 Playground Improvement Annual Projects – 3 Years

WHEREAS the *ministère de l'Éducation (MEQ)* approves budgets for playground improvement projects yearly under the program *EMB – Embellissement des Cours d'Écoles – Mesure: 50530*;

**WHEREAS** the Eastern Townships School Board (ETSB) aims to benefit to the maximum from the *MEQ*'s measure 50530 being very generous;

WHEREAS for every playground improvement project, the school raises a minimum of \$10,000 from the community;

WHEREAS for every playground improvement project, the ETSB will pledge \$10,000;

**WHEREAS** the *MEQ* will contribute 90% of the overall project up to \$100,000 per school playground improvement project;

**WHEREAS** the ETSB will use the monies from its global envelope of the RTB - Réfection et transformation des Bâtiments program to assume its share of the project;

**WHEREAS** this resolution gives the right to the ETSB to request a grant under that measure for any of ETSB's schools and to accomplish the work for the years 2024-2025, 2025-2026 and 2026-2027;

IT WAS MOVED BY Commissioner M. E. Kirby to proceed with the work for the project stated above;

**IT WAS FURTHER MOVED** that the Director General be authorized to sign all associated documentation and that in the absence of the Director General, the Director of Material Resources can also sign.

Carried unanimously

The Chair of the Transportation Advisory Committee, Commissioner H. Turgeon mentioned the topics discussed at the March 18, 2025 meeting:

- O Bus drivers' recruitment update is stable;
- O Bus route cancellations (stats and functioning East and West sectors) is less than 1%;
- Allergies/Special conditions for students;
- Lion Electric update: the company has been bought, but we are unaware by whom.

### 9.8 Special Education Advisory Committee (SEAC)

In the absence of the SEAC Chair and Parent Commissioner, E. McKnight, the Director of Complementary Services, E. Gaudet mentioned the following topics discussed at the February 12, 2025 meeting:

A parent session will take place on April 9, 2025, which will be presented by Hannah Beach. The title of the session is Cellphones: What's Healthy, What's Not and What We Can Do To Support Our Kids. It is geared for parents of elementary and secondary school students. An invitation will be sent out to all ETSB parents by email on March 27, 2025. It will also be advertised the SEAC Facebook page.

The date of the next SEAC meeting is scheduled for May 21, 2025.

### 10. PARENTS' COMMITTEE

The Commissioner representing parents, S. Langlois mentioned the topics discussed at the March 12, 2025 meeting:

- ESAC priorities and overview presented by E. Gaudet and E. Lettner:
  - ✓ Monitoring the implementation of educational projects and action plans;
  - ✓ Research and implementation of evidence-based practices surrounding student engagement and collective efficacy.
- Parent participation brainstorm Governing Board promotion:
  - ✓ Short video clips shared on social media;
  - ✓ Effective way for parents to share their ideas with GB members. Make the meetings more interesting. Parents will realize they have a voice.
- O Cell phone discussion it was mutually agreed that cell phones have no place in class and should only be used as a safety measure. Students were taught how to use their phones responsibly. Policies should be more clearly defined;
- April, May and June meetings will be hybrid.

### 11. STUDENT ADVISORY COMMITTEE

In the absence of Commissioner J. Humenuik, representing the Student Advisory Committee, the Director of Instructional Technology, E. Lettner mentioned the following:

  - ✓ Student's opinions and ideas were heard;
  - ✓ Sports and extracurricular activities were discussed;
  - ✓ Snacks in the vending machine now available;
  - ✓ Tour of the school:
  - ✓ Al was also discussed.

The date of the next Student Advisory Committee meeting is to be determined.

### 12. QESBA

Chair M. Murray mentioned the following updates:

- O Spring Conference: there has been an overwhelming response resulting in shutting down registration due to the fact that there are no more hotel rooms available.
- Funding: the Legal Defense Fund campaign against Bill 40 and 21 is underway. We are also going to end up challenging Bill 86 and 96, which is impeding on our rights. Relaunching the fundraising will support ongoing costs to major campaigns in the Supreme Court of Canada. So far, we have managed to raise 600K, but spent close to 1.1M. The rest is QESBA reserved. We are asking for possible donors.
- New Professional Development training program: in collaboration with Alain Vachon, who is an excellent guide and presenter. He developed a certification program for Commissioners or trustees, which will take place as five Saturday workshops on different themes at no extra cost. Once the training is complete, the Commissioners receive an official title.
- Office québecois de la langue française (OQLF) annual survey: we believe this is an attempt at intimidation for our employees further pushing secularism. The Deputy Minister of Education has issued a deadline for April 4, 2025 to update our Code of Ethics, for all groups of employees, staff and volunteers, but after legal council, English school boards are exempt from the deadline. We need to look at this properly before going forward.

### 13. COMMISSIONER'S COMMENTS AND QUESTIONS

Commissioner G. Barnett: Lennoxville Vocational Training Centre (LVTC) Governing Board

<u>Educational Project</u>: Although the Educational Project Committee had difficulty to find time to meet, some changes have been made which now goes back to consultation.

<u>Calendar</u>: Due to the delay in the finalization of the Youth Calendar because of Local Agreements, the LVTC Calendar has also been delayed.

<u>Teacher's handbook</u>: This has been updated with information on issues such as Institutional & Home Care Assistance Program (on hold) now replaced by SASS (Support for Assistive Services in Health and Social Services Institutions), Health & Nursing for LPNs, Welding and Assembly, a direct link to the travel expense form and other changes.

<u>Planning</u>: Because there were fewer students than expected, a review of personnel and contracts will be needed to develop the budget. This could affect six teachers, some put on hold, and may affect even any tenured or tenure-track people at 90%.

<u>Contacts</u>: Working with Townshippers, contact with MRCs and businesses has been made to promote LVTC services.

<u>SVI</u>: They are working more and more with the Adult Sector in programs such as SVI to promote the services of both groups and will be present at the *Salon Carrière* at Bishops.

Plumbing & Heating: This new venture generated a lot of interest resulting in numerous interviews.

<u>Masters Challenge</u>: LVTC organized some painting activity for the new employees to discover LVTC.

### <u>Alexander Galt Regional High School (AGRHS)</u>

Spring Play: It Happened On Route 66 – GALT will present their Spring Production play on April 10<sup>th</sup>, 11<sup>th</sup> and 12<sup>th</sup> at 7:30 p.m. in the Auditorium.
